(a) INTRODUCTION:

(1) TACOM is issuing this solicitation under the authority of Federal Acquisition Regulation (FAR) Part 12, which creates a simplified contract format we can use to buy commercial items, using techniques that are similar to those used in private-sector contracting.

(2) This solicitation will be different from those you may have received before. Many of the clauses and provisions used here were created specifically for commercial acquisitions issued under FAR Part 12. A great many clauses that normally appear in Government contracts do not appear in this solicitation. However, this is a complete solicitation, containing all the clauses we intend to apply to the resulting contract. Note also that the old Uniform Contract Format, with its Sections A through M, has not been used in this acquisition. In the event of termination for cause, the Government shall not be liable to the Contractor for any amount for supplies or services not accepted, and the Contractor shall be liable to the Government for any and all rights and remedies provided by law. If it is determined that the Government improperly terminated this contract for default, such termination shall be deemed a termination for convenience.

(n) Title. Unless specified elsewhere in this contract, title to items furnished under this contract shall pass to the Government upon acceptance, regardless of when or where the Government takes physical possession.
