1. The purpose of Modification P00001 is to reduce the quantity of this contract from a quantity of 4 to 3. The cost of making one additional locking plug is not cost effective for this small business.
2. This modification resulted in a reduction in contract price of \$127.80 from \$511.20 to \$383.40.
