(a) Current Output Test:

Hot stabilized SAE Method (SAE J5441b) test to be run at 1000 RPM, 2000 RPM, 3000 RPM and 5000 RPM with .2 OHM resistance inserted in the field circuitsimulate the regulator. The output shall not be less than the performance curves of drawing K10947517 Figure A.

(b) High Potential Test:

The Alternator shall pass a 500 volt minimum, 60 cycle voltage test from field terminal to ground and from positive output terminal to ground for a period of five seconds minimum each.

(c) Heat Run:

Run the Alternator for 15 minutes at 2750 RPM. Maintain 28.0 plus or minus .1 volts and 100 amps, with the regulator in circuit. After 15 minutes of operation, increase load to get maximum amps at 27.5 volts with regulator removed and 0.2 OHM total resistance in field circuit. Amperage shall be 103 minimum and recorded.

(d) Overspeed Test:

The Alternator shall be run with no load and open field circuit at 10,000 RPM for a period of on (1) minute. There shall be no mechanical injury during during this test.

(e) Balance Speed Check:

At 2750 RPM adjust load to maximum amps with volgage between 27.5 to 28.1 volts with regulator removed and 0.2 OHM total resistance in field circuit. Record volts and amps. Amps to be 100 minimum. Reject unit below 100 amps.
