DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

Scope of Work FUEL TANK SELF-SEALING (FTSS) SOLUTION

Background: An urgent requirement exists to identify and test technical solutions to prevent and/or minimize fuel leakage from M969 / M967 5000 Gallon fuel tankers when penetrated by small arms fire including 7.62mm LPS rounds at muzzle velocity and 0 degrees obliquity. The technical solution must be available for installation on M967/M969 tankers in Iraq and Kuwait and must not degrade the required performance characteristics of either the tankers or the prime mover. A spray on fuel tank self-sealing (FTSS) solution has been proposed to meet this requirement. The Army intends to conduct ballistic testing and up to a 3000 mile automotive test, to include a hot chamber test, in order to validate the proposed solution.

Requirements:

C.1 Ballistic Testing:

a) Test Sample: The contractor will deliver two test samples, suitable to provide valid test data that would simulate the results of FTSS application on a M967/M969 fuel tanker, for ballistic testing. At a minimum, the test sample will consist of a 7 or 8 gauge, stainless steel 55 gallon drum (replicating the tanker vessel) capable of simulating head pressure equal to 3 psi when J8 fuel is added and the drum is capped.

b) The contractor will apply FTSS coating to one of the test samples at their facility prior to delivery. The FTSS coating will demonstrate the capability of self sealing and preventing fuel leakage when penetrated by small arms fire including 7.62 LPS mm rounds at muzzle velocity and 0 degrees obliquity. . In addition to the test samples, the contractor will provide a videotape documenting the application process to the test sample coated at their facility. A complete description of the FTSS solution, any existing empirical test data of the FTSS solution relevant to this requirement, and a Material Safety Data Sheet (MSDS) for each component of the FTSS will be furnished with the test samples.

c) One test sample and contractor technician (see paragraph C.4 below) will be available at Aberdeen Test Center for ballistic testing not later than (NLT) 0800 hours on 13 Oct 04. The technician should coordinate with Kevin Betz, phone: (410) 278-1166 or Mark Simon, phone, (410) 278-1446 at least 8 hours prior to arrival.

The second test sample will be delivered to the above address NLT 15 Oct. 04. The FTSS coating will be applied to this sample at Aberdeen Test Center.

C.2 Automotive/ Hot Chamber Testing:

a) The contractor will furnish all supplies and personnel necessary to apply the FTSS to a Government Furnished M969 Fuel Tanker at Aberdeen Test Center no later than (NLT) 15 Oct 04. The contractor will perform all services necessary to apply the FTSS solution to the tanker, including all preparation and cleaning of the Fuel Tanker required prior to FTSS application.

b) The Government will provide one M969 Fuel Tanker suitable for FTSS application (no major dents or paint peeling) along with sufficient space in a bay area for FTSS application. The Government will also provide scaffolding or a cherry picker to allow access to spray the top of the tanker.

c) The contractor will demonstrate application procedures and verify the application process to insure the performance characteristics of the tanker and prime mover are not degraded and coverage is sufficient to prevent and/or minimize fuel leakage from M969 / M967 5000 Gallon fuel tankers when penetrated by small arms fire including 7.62 LPS mm rounds at muzzle load velocity.

d) An automotive test of up to 3000 miles may be conducted on the tanker coated with FTSS to demonstrate the durability and adhesion of the FTSS coating and the impact on the performance of the tanker and prime mover. A hot chamber test will also be performed to simulate climate conditions (up to 130 degrees F) in Iraq and Kuwait and demonstrate the effects of various temperatures on the FTSS.

C.3 Repair Kit and Procedures:

a) The contractor will furnish one tank vessel repair kit and written repair procedures. The contractor will demonstrate the repair kit and procedures on the test sample drum (C.1 a) at the conclusion of ballistic testing. This requirement may be waived if the ballistic testing renders the sample unusable for demonstration purposes.

C.4 Contractor Tests Support:

a) The contractor will provide at least one technician on-site at Aberdeen Test Center during the Government ballistic and automotive testing. The technician will have the necessary expertise in the FTSS process to provide technical assistance to the Government testers and respond to any test incidents. Period of performance for Government Testing at Aberdeen is 13 Oct 04 20 Oct 04. This time frame may be extended at the Governments option

c) The contractor will insure that sufficient replacement materials will be available for immediate application/repair in case of loss of FTSS coating during test. The contractor will apply replacement FTSS coating as necessary to preclude any loss of test time.

C.5 The following notice applies to this order and must be included in all subcontractor purchase orders. This material is being purchased to support a US Army Contract that is DPAS rated DO. This effort is for the production of Armor/ Ballistic Protection for the M969/M967 series Tankers for the US Military in Iraq. The material being requested is critical to the force protection for our soldiers. Per 15 CFR 700 Section 700.12 (d) this is a DO rated order certified for national defense use, and you are required to follow all provisions of the defense priorities and allocation system regulation.
