1. This Modification 75 to Delivery Order 0266 under Requirements Contract W56HZV-07-D-M112 is a supplemental agreement.
2. Conditional Acceptance. The conditional acceptance terms and conditions specified in Modifications 17, 26, 46, 48, 56, 60 AND 66 are hereby augmented. Except as stated below, all other terms and conditions of Modifications 17, 26, 46, 48, 56, 60 AND 66 remain in effect.
3. Conditional Acceptance Agreement.
 - a. The conditional acceptance of DVH vehicles is contingent upon full compliance with the terms and conditions of this modification. Failure to meet any requirement contained herein, or failure to comply with any milestone identified in this modification, any retrofit or corrective action requirements or any other condition of the modification, may upon PCO review be grounds for revoking this modification and may end the conditional acceptance agreement.
 - b. Furthermore, the Contracting Officer may suspend this vehicle conditional acceptance agreement based on the Contractor's failure to comply with other Stryker Program contractual agreements.
4. DVH vehicles scheduled for delivery in December 2012 may be conditionally accepted under the following conditions:
 - a. Vehicles may be conditionally accepted with functional, reclaimed heaters, part number 10664283-001. GDLS shall provide to PM-SBCT, DCMA and CLS a matrix of the 20 heaters obtained through Government stock no later than 15 January 2013. The matrix shall at a minimum contain whether the heater is new or reclaimed, serial number of the vehicle that it is installed in, and the serial number of the heater. A Product Quality Deficiency Report (PQDR) shall be written if the heater is defective.
5. As a result of this Modification 75, the total price of Delivery Order 0266 is neither increased nor decreased. Except as specifically stated above, all other terms and conditions of Delivery Order 0266 remain unchanged and in full force and effect.
