Household items include, but are not limited to, appliances and furniture, such as refrigerators, stoves, microwave ovens, washing machines, televisions, VCR's toasters, blenders, kitchen utensils, dishes, silverware, and other miscellaneous items required to adequately furnish apartments/living quarters.

H.1.2 The above household items are not acquired for use in, nor do they effect, direct performance of the Contract. These items are considered to be Personnel Support Services (PSS) associated with the life support of program personnel and purchased in accordance with Paragraph C.2.4.4 of the Contract. The Contracting Officer has determined that they will be managed and disposed of as follows:

H.1.2.1 The Contractor is authorized to dispose of household items that have not been consumed through use by either having its employees purchase the items directly or by selling the items to interested parties in Egypt. Prior to disposal by either method, the Contracting Officer must determine whether the purchase and/or sale price of the household item is fair and reasonable. Any proceeds from the purchase and/or sale must be credited against the Contract. In the event that neither purchase nor sale is available, then the Contractor must transfer the household items to the Government of Egypt.
