## SCOPE OF WORK

C.1 The contractor shall provide an instructor to instruct government/Marine Corps operators and maintenance personnel utilizing the existing Light Armored Vehicle Command and Control (LAV C2A2) training curriculum and course materials as provided by the Government and listed in Attachment 0001. The contractor shall instruct using this training package, which includes new equipment training (NET) and instructor and key personnel training (I&KP) in four complete sessions. A complete session consists of a one calendar week course for operators and a one calendar week course for maintainers.

C.1.1 The contractor will utilize two LAV C2A2 Upgrade vehicles with SL-3 gear, which will be provided at each training site to conduct the classes. Each vehicle will enable the maximum of six students to acquire the necessary hands on training the curriculum requires. Each class will contain no more than 12 students. The complete list of GFM is located in Attachment 0001.

C.1.2 The contractor shall provide up to two instructors per vehicle.

C.1.3 The contractor will have one business week prior to the first training session to familiarize itself with the vehicle platform and the training materials. LAV platforms will be made available to the contractor in order to familiarize itself with the training requirements. This familiarization will take place on-site of the first training evolution prior to the commencement of the first official training session.

C.1.4 At the end of the familiarization period, the contractor shall conduct a dry run training session consisting of two to four business days in front of the Contracting Officer's Representative (COR).
