DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

Title: POLYURETHANE FOAM FOR EXPLOSION MITIGATION IN MILITARY GROUND VEHICLES

Definitions:

a. The following scope of work includes "Required" and "Desired" requirements. The "Required" requirements represent threshold requirements which must be met in order for the items to be inspected and accepted for payment. The "Desired" requirements represent objective requirements which the contractor, consistent with the contractor's technical proposal as evaluated for award, will utilize its best efforts to achieve.

b. The following scope of work includes the terms "Primary fuel storage device" and "Secondary fuel storage device". The "Primary fuel storage device" means part number 5582606 (NSN 2910-01-263-3224, the fuel tank for the HMMWV). The "Secondary fuel storage device" means part number MIL-C-53109 (NSN 7240-01-337-5269, the 5 gallon fuel can).

C.1.1 Statement of Work:

The U.S. Army Tank Automotive and Armaments Command (TACOM) will procure, test (IAW the Test Plan included as Attachment 002), and evaluate Polyurethane Foam ("Safety Foam") as one possible means by which to mitigate the risk of explosion and fuel sustained fires in the primary fuel storage device of military ground vehicles and supplemental fuel storage devices carried as cargo.

C.1.2 Background:

Requirements do not exist within the U.S. Army Tank Automotive and Armaments Command for polyurethane foam as an explosion mitigation method for military ground vehicles.

C.1.3 Objective:

The objective of this contracting effort is to permit the evaluation of the suitability of polyurethane foam as an explosion mitigation solution in military ground vehicles, while affording the U.S. Army a basis for comparison with non-foam based systems.

C.1.4 Deliverables:

a. Four (4) part number 5582606 (NSN 2910-01-263-3224, "Tank Assembly") and four (4) part number MIL-C-53109 (NSN 7240-01-337-5269, "CAN: fuel, steel, MIL type, 5 gal.") installed with the Contractors proposed flame arresting polyurethane foam.

b. Eight (8) additional cubic feet of the same type of polyurethane foam used in part numbers 5582606 and MIL-C-53109 for evaluation and testing by the Government.

Note: The polyurethane foam cannot be exposed to any fuel prior to its submission to the government.

C.1.5 Required:

a. The polyurethane foam shall be flame arresting and of the type designed to prevent explosions and fires in fuel tanks filled with JP-8 fuel.

b. The polyurethane foam will not require reinforcing the supporting hardware of primary and supplemental fuel storage devices.

c. The polyurethane foam shall resist degradation when exposed to JP-8 fuel.

C.1.6 Desired:

Notice: The following applies to both the primary and supplemental fuel storage devices, unless indicated otherwise.

a. In order to minimize fuel discharge and the risk of incineration caused by fuel loss, it is desired to have 95% to 100% fuel containment in a penetrated fuel storage device.

b. In order to minimize the risk of incineration, it is desired to have at least one hour of explosion and incendiary protection once a fuel storage device is penetrated by the first threat.

c. The polyurethane foam should not increase the temperature of JP-8 fuel in a fuel storage device,

d. The polyurethane foam should not accumulate an electrical potential,

e. The polyurethane foam should not hold or attract airborne moisture,

f. The polyurethane foam should not promote microbial or fungal growth, wax formation, or particulate precipitation,

g. The polyurethane foam should not degrade military ground vehicle crashworthiness once retrofitted (applies only to the primary storage device),

h. The polyurethane foam should not fracture or become unstable or rupture a fuel storage device when exposed to alternating temperature cycles (-50 F to 120 F) and vibration/inertia caused by vehicle operation.

i. The polyurethane foam should have no effect on fuel flow in hot (120 F) or arctic (-50 F) climates nor impact fuel refill procedures, and

j. The polyurethane foam should be removable for inspection.

k. When used in primary fuel storage devices ground vehicle range should not degrade more than five miles of the maximum range. When used in supplemental fuel storage devices the usable fuel capacity of the storage device should not degrade by more than 5%.

l. Explosion mitigation should be provided against 7.62 mm Armor Piercing Incendiary (API) rounds traversing liquid, or vapor, or liquid and fuel-vapor mixed with atmospheric air within the fuel storage device.

C.1.7 Performance Period:

The performance period for preparing and installing polyurethane foam into Government Furnished Material (GFM) and delivering that material, along with the additional eight (8) cubic feet of polyurethane foam, to the designated Government test facility for evaluation and testing is forty-five (45) days from the date of receipt of the Government Furnished Material. All material submitted to the Government by an offeror is subject to inspection for content and damage prior to acceptance. All material once accepted becomes the property of the Government.

C.1.8 Government Furnished Material (GFM):

The U.S. Army Tank Automotive and Armaments Command will supply to the Contractors facility within thirty (30) days from the date of award, for each selected proposal the following:

1) Four (4) part number 5582606 (NSN 2910-01-263-3224, "Tank Assembly"), and

2) Four (4) part number MIL-C-53109 (NSN 7240-01-337-5269, "Can: Fuel, Steel, MIL type, 5 gal.").

See Attachment 001 for the drawings for the above part numbers. An offeror is responsible for preparing and installing polyurethane foam into the GFM and delivering that material to the U.S. Army Aberdeen Test Center (ATC) for evaluation and testing. Submitted material

The U.S. Army Tank Automotive and Armaments Command will not provide military ground vehicles or any JP-8 fuel for this initial effort.

C.1.9 Travel/Security:

To ensure consistency all testing will occur at the U.S. Army Aberdeen Test Center (ATC). Contractor representatives may observe penetration testing of their product, subject to the policies and security restrictions of the test facility. A contractor is responsible for travel expenses associated with observing penetration testing of its product.

EVALUATION CRITERIA FOR AWARD

M.1 General: The Government plans to award up to three contracts for the installation of Polyurethane Fire Safety Foam into government furnished material and for an additional eight (8) cubic feet of Polyurethane Foam. The evaluation of proposals submitted in response to this solicitation shall be conducted on a source selection basis utilizing a "trade-off" process to obtain the best value to the Government.
