3.2. Scope. The contractor will supply the labor, parts, materials, equipment, services and facilities needed to return unserviceable GLPS components to supply condition code A (serviceable - issuable without qualification) . The contractor will also reset (return complete systems to condition code A) GLPS IAW these requirements. All unserviceable components and GLPS delivered to the contractor for repair or reset is Government Owned (GO) Government Furnished Material (GFM).

3.4. Unserviceable component turn-in. The TACOM GLPS Item Manager (IM) will be the POC responsible for directing shipments of unserviceable GFM (repairable components) to and from the contractor for repair. The contractor will contact the IM for disposition instructions whenever non-scheduled (non-coordinated with IM) GFM is delivered to the contractor's repair facility. Gyroscopes, Theodolites and Battery Chargers will be shipped to and from the contractor in the shipping and storage containers issued with the system. Excess components mistakenly shipped to the contractor within the Gyroscope, Theodolite or Battery Charger storage containers,
