1. Modification 18 to Delivery Order 0079 to Contract DAAE07-00-D-S022 is an administrative Modification linked to Delivery Order 0118 Modification 20. Delivery 0118 Modification 20, de-obligates funds in the amount of \$250,000.08 from CLIN 1001AA. Daimler invoiced these vehicles for FRET, and then the Government decided to send these vehicles overseas and needed to remove the FRET on 11 vehicles from CLIN 0002AA on Delivery Order 0079. Daimler did not invoice for the \$507,656.00 on CLIN 1001AA for 2 years; therefore no interest is due to the Government.
2. All other terms and conditions of the Contract remain unchanged and in full force and effect.
