- 2) CLIN 0004AA, quantity of 12 each Diesel Engines is hereby deleted in its entirety.
- 3) The amount of modification P00001 is hereby reduced by \$371,736.00 from \$371,736.00 to \$0.00.
- 4) The contractor hereby unconditionally waives any claims whatsoever arising under the contract or by reason of the total cancellation effected in paragraph 1) above, and the Government hereby releases the contractor from any obligation to perform or make deliveries under this contract or for any claim whatsoever against the contractor arising under this contract.
