1. The purpose of modification 01 to delivery order SPRDL1-15-D-0011 0001 is to remove the reference to the signed PCO letter issued to Oshkosh Defense, update the DoDAAC and other codes for Oshkosh's facility and revise the delivery schedule due to a government-caused delay.

2. Therefore, the reference to the signed PCO letter issued to Oshkosh Defense dated 18 Dec 2014 is hereby removed from the delivery order. The 54 each Modulator Assembly units under delivery order 0001 will be sent to Oshkosh's facility as Government Furnished Material (GFM).

3. Oshkosh Defense is utilizing Government Furnished Material (GFM) to support refurbishment (reflash) of the 54 each Modulator Assembly units. FOB Origin inspection and acceptance will take place at the contractor's facility, Cage 75TU0, 5211 3rd Street, Milwaukee, WI 53207-6006. The DoDAAC is CK0UJZ, the RIC code is CD7 and the Plant code is 9881.

4. Due to a government-caused delay in obtaining the proper codes for Oshkosh's facility, the delivery schedule is being extended from 54 each delivered by 31 Aug 2015 to 28 Oct 2015.

5. All other terms and conditions of the basic contract remain the same and in full effect.
