The purpose of Modification 08 to Delivery Order W52H09-09-D-0085 BR06 is the following:

1. To correct the quantity listed in #2 on all prior modifications relating to this delivery order. #2 has previously stated:

"The total amount of Squad Kits originally ordered on Delivery Order W52H09-09-D-0085 BR06 was 118 Sets. 14 of those have already been fielded via Item Manager issuing instructions."

14 Sets is an incorrect figure. The number of kits that were actually fielded via Item Manager issuing instructions was 13. Therefore, #2 will be changed to state:

"The total amount of Squad Kits originally ordered on Delivery Order W52H09-09-D-0085 BR06 was 118 Sets. 13 of those have already been fielded via Item Manager issuing instructions."

Thus, the additional information listed under #2 is incorrect as well. The change to be made is as follows:

FROM:

The remaining balance to be shipped for CLIN 0003AA is 21 Kits.
The remaining balance to be shipped for CLIN 0003AB is 08 Kits.

TO:

The remaining balance to be shipped for CLIN 0003AA is 22 Kits.
The remaining balance to be shipped for CLIN 0003AB is 08 Kits.

2. There are no other changes as a result of this modification. All other terms and conditions of Contract W52H09-09-D-0085 apply to Delivery Order BR06 and remain unchanged.
