1. This Modification 59 to Delivery Order 0046 under Requirements Contract W56HZV-07-D-M112 is a supplemental agreement.
2. The purpose of this modification is to augment a Noncompliant Brake Systems - FMVSS 121 conditional acceptance term and condition for withhold recovery originally established under Modifications 36 and 48. Except as stated below, all other conditional acceptance terms and conditions remain in effect.
3. As a result of this Modification 59, Modification 36 Paragraph 14.b.ii and Modification 48 Paragraph 10.b.ii are changed from:
"The Government agrees to release the price withholds for the above paragraphs, within 30 days after submittal of the completed appropriate acceptable documentation/invoice and a signed ECAR."
changed to:
"The Government agrees to release 75% of the material withhold when the Contractor certifies via DD1149 or equivalent, and an authorized Government representative verifies, that compliant parts/material are available for vehicle application. The Government agrees to release the price remaining 25% withhold for the above paragraphs within 30 days after submittal of the completed and a signed ECAR."
4. As a result of this Modification 59, the total price of Delivery Order 0046 is neither increased nor decreased.
5. Except as specifically stated above, all other terms and conditions of Delivery Order 0046 remain unchanged and in full force and effect.
