1. This is a bilateral modification at no additional cost to the Government.
2. The purposes of Modification P00060 are to:
 - a. Extend the period of performance of Work Directive 0042 by approximately six (6) months and change the expiration dates on CLINs 0001BW, 0001CY, 0001CZ, and 0001DP from 31 March 2014 to 30 September 2014.
 - b. Incorporate WD 0042 revision 3 by reference.
