Modification P00070 - Work Directive 016 Revision 004

1. This modification P00070 to contract W56HZV-09-C-0100 is a bilateral supplemental agreement pursuant to clause 52.243-2, Changes Cost Reimbursement Alt V.
2. The purpose of this modification is to incorporate Revision 004 to Work Directive 016 (WD 016 Rev 004) and extend the period of performance for WD 016 by six months.
3. The parties agree that the changes set forth in WD 016 Rev 004 are at NO COST to the Government. WD 016 Rev 004 will be issued to the contractor under separate cover.
4. As a result of this modification, Section B of the contract is revised to extend the performance completion date for CLINS 0001BA and 0001BG to 30 November 2014.
5. There is no funding associated with this modification. The obligated amount of the contract remains unchanged at \$29,985,108.34.
6. Except as specifically stated above, all other terms and conditions of the contract remain unchanged and in full force and effect.
