1. The purpose of this bilateral modification P00051 to contract W56HZV-09-C-0408 is to incorporate the below action pursuant to FAR 52.243-1, Changes - Fixed Price.

a. Extend the conditional acceptance previously authorized by Modifications P00040, P00043 and P00047 of this contract due to the Auxiliary Power Unit Assembly (APU) Part Number 12367093 non-conformance.

2. APU Conditional Acceptance:

APU Conditional Acceptance Vehicles scheduled to be delivered under SLINs 0015AA and 0016AA for October 2013 will be conditionally accepted with the APU non-conformance.

a. The withhold remains \$32,400 per vehicle, as required under Paragraph 2b of Modification P00040.

3. The conditionally accepted vehicles will remain at BAE-York for an extended length of time while these issues are resolved, unless otherwise directed by the USG. While the conditionally accepted vehicles remain at BAE-York, the contractor shall perform cyclic maintenance on the vehicles as specified in the M88A2 FIR Appendix A M88A2 Storage and Maintenance Plan, at contractor expense until approved corrective action, testing, and DCMA validation is completed.

4. This action will be executed entirely at the contractors expense without any equitable adjustment to any Government contract.

5. This conditional acceptance does not constitute a waiver by the Government of any rights, contractual, statutory or otherwise relating to any matter involving the production or delivery of these parts and does not waive any claims by the United States Government for fraud, false claims, or any other conduct on the part of any party which may be actionable under law. Specifically, this conditional acceptance does not waive any rights by the Government for any vehicle delivered under this contract that is found to contain this condition in the future.

6. As a result of this Modification P00051, the total amount against W56HZV-09-C-0408 remains unchanged.

7. All other contract terms and conditions remain in full force and effect.
