1. The purpose of this Modification 02, Task Order 0019 is to fund SLIN 0026AB for the RESET of USMC MGB #2.
2. The Medium Girder Bridge (MGB) #2 SLIN 0026AB shall be RESET in accordance with (IAW) Section C of Base Contract W56HZV-09-D-0116 and Conditional Assessment Report (CAR) USMC MGB #2 dated May 2013.
3. The exchange rate used in CAR USMC MGB #2 was the baseline contract exchange rate of 1.5 US Dollars to 1 GBP. The exchange rate as of September 04, 2013 11:37:13 GMT is 1.5612 US Dollars to 1 GBP. The exchange rate adjustment computed is IAW H.5.4 (2):  
 $1.5612 / 1.5 = 1.0408$   
 $\$700,436.90 \times 1.0408 = \$729,014.73$
4. As a result of this modification, the task order has been increased by \$729,014.73 from \$2,201,012.19 to \$2,930,026.92.
5. IAW Section C.45, a Performance Based Payment Schedule will be negotiated and implemented at a later date.
