The purpose of modification P00045 to contract W56HZV-11-C-0114 is to make the following change.

1. Change the following language to Work Directive 001 Rev 010, Section 5.2.

From:
 Training under paragraph 5 will be up to four (4) months, and training under paragraph 5.1 will be up to nine (9) months in duration per Kandak/Training group, based on the approved MT schedule, IAW CDRL A017. Training shall take place at Home Station forward operating bases (FOB), Corps Logistics Kandaks (CLK), Forward Supply Divisions and at the National Depot level at Kabul and Kandahar. The contractor shall provide a POI, lesson plans, instructor training aids, and sufficient training material in both English and Dari languages, IAW CDRL A016. The contractor is authorized to extend the OJT beyond nine (9) months with COR approval.

To:
 Training under paragraph 5 will be up to four (4) months, and training under paragraph 5.1 shall be a minimum of (9) months, but may be extended beyond (9) months at the recommendation of the contractor per Kandak/Training group, based on the approved MT schedule, IAW CDRL A017. Training beyond the (9) months shall be approved by the COR. The OJT shall not extend past the period of performance of the Work Directive. The contractor shall include in the notification whether the funding and man-days available is sufficient to extend the OJT without impacting other Kandak training. Training shall take place at Home Station forward operating bases (FOB), Corps Logistics Kandaks (CLK), Forward Supply Divisions and at the National Depot level at Kabul and Kandahar. The contractor shall provide a POI, lesson plans, instructor training aids, and sufficient training material in both English and Dari languages, IAW CDRL A016.

2. The services under the time extension must be performed within the current funds and man-days on contract.
3. As a result of this action the contract value has not changed.
4. All other terms and conditions of the contract remain unchanged and in full force.
