NOTICE OF TERMINATION

1. Pines Automotive, Inc. (Pines Automotive) is hereby notified that contract W56HZV-11-D-0094 is terminated in accordance with clause 52.249-8 entitled Default (Fixed Price Supply and Service).
2. Pines Automotive is in default due to its failure to deliver 1 each First Article Test Report and 255 each, Plunger, Quick Release, NSN 5340-01-531-3270, Part Number 11581695 per the terms of contract W56HZV-11-D-0094 and delivery order W56HZV-11-D-0094/0001.
3. Pines Automotive failed to provide an acceptable reason to the Contracting Officer for their inability to perform under the contract. Their failure to provide an acceptable reason for not performing under the contract is construed as an admission that no fault outside of their own exists for non performance.
4. Pines Automotive is hereby instructed that its rights to proceed further with the performance of this contract are terminated. Immediately stop all work, terminate all subcontracts, and order no further supplies or equipment. Provide similar instructions to all subcontractors and suppliers.
5. The supplies terminated may be purchased against Pine Automotive's account and Pine Automotive will be held for any excess costs.
6. The Contracting Officer hereby determines that Pines Automotive's failure to perform is inexcusable. The Notice of Termination for Default letter dated 17 October 2013 constitutes the Contracting Officer's final decision that Pines Automotive is in default.
7. The Government reserves all rights and remedies provided by law under the contract, in addition to charging excess costs.
8. Pines Automotive has the right to appeal this decision under the Disputes Clause of the contract.
