1. Transfer accountability of Government Property from this contract (W56HZV-12-C-0133) to Honeywell TIGER II contract W56HZV-12-C-0344.
2. Delete Attachment 0001, Government Furnished Property/Material, from Section J in order to remove accountability of Government Property from this contract (W56HZV-12-C-0133), which has already been assigned to Honeywell under TIGER II contract W56HZV-12-C-0344.

II. AS A RESULT OF THIS MODIFICATION:

1. Transfer two gas turbine engines, NSN 2835-01-548-2910, and one M1A2 Abrams Tank, NSN 2350-01-328-5964, from this contract (W56HZV-12-C-0133), to contract W56HZV-12-C-0344. Serial numbers of engines being transferred are T08F057 and T12F007. The serial number of the Abrams Tank being transferred is LRV160M. The gaining modification for contract W56HZV-12-C-0344 is modification P00011.
