1. The purpose of this Modification P00003 is to rescind, as it pertains to default, the previously issued Modification P00002, Termination for Default, and to instead issue a Termination for Convenience. All other provisions of Mod P00002 remain in effect.
2. The contractor hereby unconditionally waives any claim against the Government arising from this cancellation or by reason of its cancellation, including without limitation, all obligation of the Government to make payments or to carry out other undertakings in connection with this action, and the Government acknowledges that the contractor has no obligation to perform work or service or to make deliveries of material under this action P00003.
3. In accordance with FAR 49.603-6:
 - a. This supplemental agreement modifies the contract to reflect a no-cost settlement with respect to the notice of termination dated 30 Sep 2013.
 - b. The parties agree as follows: The Contractor unconditionally waives any charges against the Government because of the termination of the contract and releases it from all obligations under the contract or due to its termination. The Government agrees that all obligations under the contract are concluded.
4. As a result of this Modification, there is no change in funding as all funding was previously de-obligated by Modification P00002
