1. The purpose of this unilateral Modification P00001 is to provide incremental funding in the amount of \$579,966.07 in accordance with paragraph B.2.2 entitled "Funding Schedule".

2. The contract is hereby modified as follows:

SECTION B:

- i. SubCLIN 0001AB is added and funded (PRON: R33SB079R3) in the amount of \$579,966.07.
- ii. Paragraph B.3 is revised to reflect the amount of funds currently allotted to this contract as \$999,907.07.
- iii. Paragraph B.3.2. is revised to state that SubCLIN 0001AB is established for the second increment of funding in the amount of \$579,966.07.

SECTION G:

The applicable accounting data is hereby incorporated into the contract.

- 3. The contract obligation is increased by \$579,966.07 from \$419,941.00 to \$999,907.07.
- 4. The negotiated value of the contract remains unchanged.
- 5. As a result of this Modification P00001, this contract is fully funded.
- 6. Except as provided by this Modification P00001, all other terms and conditions remain unchanged.

B.1 ESTIMATED COST & PAYMENT

B.1.5 The fee will be payable at the time of reimbursement of cost in the same proportion to such cost as the total fee of this contract bears to the total estimated cost thereof, subject to any withholding pursuant to provisions of this contract.

B.2 FUNDING

B.2.1. The Government will provide funds under this contract covering the estimated cost and fee on an incremental basis, as provided for in the funding schedule below and pursuant to the following Contract Clauses:
