1. The purpose of Modification P0004 to contract W56HZV-13-C-0368 is as follows:
  - a. Mod P00002 was awarded on 25 March 2014 to changed the contractors cage code from 64R10 (manufacturing location) to 1BHV9 (corporate office). When the cage code was updated it also updated the Defense Finance and Accounting Services (DFAS) Pay Office code from HQ0339 to HQ0338. DFAS submitted CDR C76461 to have a Modification created to state that the Pay Office for Contract W56HZV-13-C-0368 is HQ0338 and not HQ0339.
  - b. The Payment Office for Contract W56HZV13C0368 is HQ0338.
2. As a result of this Modification P00004 the total obligated dollar amount is not changed and remains \$4,855,224.49.
3. All terms and conditions of contract W56HZV-13-C-0368 remain unchanged and in effect.
