The purpose of modification P00001 is to incorporate the following: Reference contract clause 52.210-4502, Heavy Phosphate Coating Requirement. The result of Phosphate Procedure Review & recommended Corrective Action is as follows.

1.. The proposed procedure was reviewed as requested and is NOT APPROVED. The reasons are as follows:

In paragraph 3.k., change the dry film thickness from "0.005 to 0.015 mm" to ".0004 to .0010 inches thick (0.01-0.025 mm thick)" or "0.4-1.0 mils". See paragraph 2.1 on drawing no. 8769470.

2.. Since the procedure is not approved, T.R. Machine, Inc. shall submit a revised procedure based on the above comments. The DCMAO representative at the vendor's plant must verify in writing, along with the resubmittal, that the revised procedure/procedures have addressed the above comments.
