1. The purpose of this Amendment 0008 to Solicitation SPRDL1-13-T-0124 is to allow additional time to respond to changes in the TDP as previously noted in Amendment 0002. The revised TDP is now available with those changes and is available through FedBizOpps only.
2. The date for receipt of quotes is extended from 10-Sep-2013 to 31-Oct-2013.
3. The TDP date is changed in CLIN's 0001AA and 0002AA from the old TDP date of Dec 2012, to the revised TDP date of 2013-Aug-01.
4. Clause 52.211.4072 is changed which provides instructions to interested parties to request access to the revised TDP through FedBizOpps.
