1.2.1 The USG option to exercise up to 3 additional DSESTS will have minimal GFM provided through the Federal Supply System (FSS). The Contractor is responsible for providing components that are not available as GFM; items not provided as GFM will be purchased by the USG under the appropriate option CLIN.

1.3 GOVERNMENT FURNISHED MATERIAL (GFM):

1.3.1 The Contractor shall inspect such GFM upon receipt to determine its adequate count and condition. All deficiencies discovered during this inspection shall be documented on a Quality Deficiency Report (SF form 368) and submitted to the COR by hard copy or electronic media, within 15 days from time of receipt. Handling of GFM shall be in accordance with the Contractor's Quality Program. The USG will be responsible for quality deficient as well as missing GFM.

Minutes for each meeting shall be prepared and taken by the Contractor and submitted to USG IAW CDRL A001. The USG and Contractor may agree to augment the meetings with Video-Teleconference sessions.

1.4.3 PROGRAM START OF WORK MEETING:

The Contractor shall conduct a Program Start of Work Meeting at their site, to include Integrated Logistic Support (ILS), no later than 30 days after contract award. The purpose of the Start of Work meeting is to review the scope of work of the contract, outline the plans and schedules for its implementation and establish the points of contact for the USG and the Contractor for each element of work. 1.4.5 TEST READINESS REVIEW (TRR):

1.4.6 The Contractor shall conduct the TRR with the USG 30 days prior to the start of Qualification and Acceptance testing to assure the test plan is adequate to satisfy technical and operational exit criteria in accordance with the contract specifications and requirements. The TRR shall include the following:

- (a) Milestone Schedule
- (b) Requirement modifications
- (c) System design
- (d) Test plans and descriptions (Software Test Description and Software Test Reports to be reviewed)
- (e) Configuration System Control Items (CSCIs)

1.5 DSESTS TEST PROGRAM SETS (TPS) for GoI M1A1SA:

1.5.1 DISPLAY. The M1A1SA DSESTS shall use the Maintenance Support Device to show operator messages and instructions in English. Each M1A1SA DSESTS shall have labels and markings for switches, knobs, modules, and accessory boxes in English. Connector pin and receptacle markings (alpha and numeric) shall be in English.

1.5.2 DESIGN REQUIREMENTS. No hardware design is required. Software design shall be to current US Army standards for the current M1A1SA DSESTS and incorporate GoI export Line Replaceable Units (LRU).

1.5.3 QUALIFICATION TESTING. Hardware qualification testing is not required as no new hardware is to be designed.

1.5.4 The USG reserves the right to audit the Test Program Sets (TPS) process at the Contractor's facility, after first arranging with the Contractor a mutually convenient date.

1.5.5 The Contractor shall ensure M1A1SA DSESTS shall consist of TPS, fault detection, alignment, adjustment, and testing the M1A1SA (LRU). The M1A1SA LRU testing includes software, interconnecting devices, accessory storage unit and system specific modules, using existing design US Army and GoI M1A1SA equipment.

1.5.6 TEST PROGRAM. The Contractor shall test all M1A1SA GoI DSESTS developed hardware and software. Testing shall include verification of all interfaces, accessories, and go-chain tests. All tests shall be conducted IAW the contractors approved Software Acceptance Test Procedures.

1.5.7 TPS DEVELOPMENT. The Contractor shall develop test programs sets which make maximum effective use of export and non-export version testability features integrated into the functional design of the LRU. In addition, maximum reuse of existing USG M1A1SA software shall be utilized.

1.5.8 INTERCONNECTING DEVICES DESIGN REQUIREMENT. Interconnecting devices shall be designed to maximize commonality with existing interconnecting devices to maximize design, simplicity, and testability, and to minimize cost.

1.5.9 SOFTWARE ACCEPTANCE TESTING (SAT). Prior to Validation/Verification release, the Contractor shall perform final software acceptance testing on new or changed TPS IAW the requirements of the USG approved contractor format SAT.

1.5.10 FAULT DETECTION. New or changed M1A1SA TPS shall detect 100% of all detectable faults to the Shop Replaceable Unit (SRU) level. The Contractor shall notify the USG if it cannot comply with this requirement because of LRU design limitations.

1.5.11 FAULT ISOLATION. The test program shall be designed to fault isolate failure modes to the SRU level. If testing indicates a high failure rate in a mode not depicted, then that failure shall be added to the Fault Insertion List (FIL) (see 1.5.16 below).

1.5.12 Fault insertion shall abide by the following:

1.5.13 Faults shall be entered one at a time (no more than one fault at a time). All faults listed shall be independent faults, i.e., not caused by other faults.

1.5.14 Faults must not be destructive to the LRU or M1A1SA DSESTS. Faults which could result in catastrophic failure of the LRU or the Automatic Test Equipment (ATE) shall not be inserted.

1.5.15 The USG will select up to 10% of the approved FIL for SAT of the M1A1SA DSESTS and all GoI peculiar FIL and SAT. The USG will identify faults to be inserted at the start of the SAT.

1.5.16 FAULT INSERTION LIST. The Contractor shall create a list of 100% detectable failures for changed, as well as new, LRU TPS. A detectable failure is defined as a failure which causes degradation severe enough to cause out of tolerance LRU performance and can be detected at an external I/O connector of the LRU.

1.5.17 CORRECTION OF TEST DEFICIENCIES. In the event of failures resulting from verification during SAT, the Contractor shall identify, analyze, and take corrective action of the deficiencies. The item or portion that failed shall be subject to retest at no cost to the USG, provided that the failure was not caused by defective GFM, to verify that the corrective action taken by the Contractor provides satisfactory performance IAW this contract and the Acceptance Test Procedure.

1.5.18 A SAT report shall be submitted in Contractor format, IAW CDRL A005, no later than 15 days after conclusion of the SAT.

1.5.19 M1A1SA DSESTS DOCUMENTATION. Documentation for DSESTS shall be updated to incorporate the M1A1SA GoI DSESTS TPS. The update shall consist of those items necessary to establish LRU automated test requirements and strategy to document M1A1SA GoI DSESTS TPS development, evaluation and acceptance, and to accomplish M1A1SA GoI DSESTS Operation and Support.

1.5.20 The Contractor shall notify the USG Procuring Contracting Officer (PCO) of the scheduled dates, times, and location of the software acceptance testing at least 30 days prior to start of testing. USG personnel may choose to witness or participate in the testing. The Contractor will also provide a copy of the Acceptance Test Procedures to the USG COR 30 days prior to testing.

1.6 CONFIGURATION MANAGEMENT (CM)

1.6.1 CM PROGRAM REQUIREMENTS. The Contractor shall develop and maintain a CM program in accordance with this Statement of Work (SOW). The Contractor shall notify the USG if a change to the Contractors ISO certifications occurs.

1.6.2 CONFIGURATION IDENTIFICATION/PRODUCT BASELINE. The Contractor shall maintain M1A1SA GoI TPS configuration identification and establish a product baseline. The product baseline for the GoI M1A1SA shall be updated to incorporate the M1A1 DSESTS TPS and describe the necessary "build to" requirements for the GoI M1A1SA DSESTS. 1.6.3 CONFIGURATION STATUS ACCOUNTING (CSA). The Contractor shall maintain and update the established CSA system. The CSA system shall provide identification of the currently approved configuration baseline.

After Approval of the SAT, the Contractor shall deliver IAW CDRL A005, a complete copy of the M1A1SA GoI DSESTS TDP within seven working days of the USG's request.

1.7 QUALITY ASSURANCE:

1.7.1 QUALITY ASSURANCE PROGRAM. The Contractor shall supply their Quality Program Plan which meets the requirements of ISO certifications. This plan shall be made available for review by the USG at the Contractor's facility upon request.

1.7.2 SOFTWARE QUALITY PROGRAM. The Contractor shall supply their Software Quality Program Plan (TEM-147). This Software Quality Program Plan shall meet the requirements of Institute of Electrical and Electronics Engineers Standard for Software Quality Assurance Plan (IEEE/EIA 12207.0 series) or an equivalent software quality system standard. The Contractor shall be required to submit updates to the Software Quality Program Plan to the USG for approval, only if revisions to the existing plan are required.

1.7.3 CONTROL OF NONCONFORMING MATERIAL. The Contractor, with USG Quality Assurance Representative (QAR) participation, shall maintain Material Review Board (MRB) procedure for the purpose of review, evaluation, and disposition of Type II nonconforming supplies and services. All nonconforming material which is classified as other than minor shall require a waiver and approval by the PCO.

1.8 INTEGRATED LOGISTICS SUPPORT:

1.8.1 INTEGRATED LOGISTICS SUPPORT PROGRAM. The Contractor shall plan, manage, and execute an ILS program for the M1A1SA GoI DSESTS.

1.8.2 PROVISIONING:

1.8.3 PROVISIONING SCREENING. The Contractor shall use FEDLOG, HAYSTACK, or other available USG databases for provisioning screening on the M1A1SA GoI DSESTS. National Stock Number (NSN) assignment is not required. The results of the Provisioning Screening effort shall be reflected in the Parts section of the supplemental/technical manual. If a part number does not have a NSN already assigned from the Department of Defense (DOD) database then the Contractor shall list the part number and Cage code of the manufacturer in the Parts section of the supplemental and technical manual.

1.8.4 Recommended Repair Parts and Special Tools List (RPSTL). The Contractor shall deliver to the USG 180 days after contract award, a RPSTL and supplemental RPSTL, for the M1A1SA GoI DSESTS. The list shall be in a top down break down sequence. The list shall have Source Maintenance Repair Codes and recommended quantities. The recommendations shall be 2-level maintenance. 1.8.5 The Contractor shall provide Technical Manual (TM) supplemental pages.

1.8.6 The Contractor shall provide the DSESTS TMs in English Version. The TMs shall be delivered to GoI at the completion of the base year. Current USG technical manuals shall be used as the baseline with GoI unique components inserted if applicable.

1.8.7 TM Reviews (GoI peculiar). The Contractor shall host no more than two TM reviews at their site. The purpose of the TM review is for the USG to review the data. The Contractor shall validate the maintenance and parts manuals prior to presenting to the USG. The USG will perform a verification of the TM material on the hardware. Each review will last no more than 2 working days. The Contractor shall have a Contractor validated copy of the manuals (maintenance and parts) at the TM Review for USG use. The Contractor shall have a knowledgeable person at the TM Review to assist the USG in their verification. The Contractor shall ensure that all tools and parts required for the TM Review are available at the review site. The Contractor shall take and record all minutes of the Review IAW CDRL A001. USG comments shall be incorporated into the final TMs and changed pages. TM review dates shall be established at the SOW Meeting.

1.8.8 Technical Manuals (TMs) (GoI peculiar). The Contractor shall prepare and deliver TMs that shall leverage off current existing USG and GoI data to the maximum extent possible and shall reflect M1A1SA GoI DSESTS. The Contractor shall prepare and deliver electronically, IAW A006, Preparation of Digital Technical Information, using MIL-STD-40051-2 as a guide.

1.8.9 Technical Manual Changes. If existing M1A1SA DSESTS hardware is modified, procedures are revised, or new procedures are developed by the addition of the GoI M1A1 DSESTS hardware and components, the Contractor shall validate the revised procedures for technical accuracy and adequacy of content.

1.9 PRESERVATION AND PACKAGING:

1.9.1 Each M1A1SA DSESTS hardware and associated material delivered to GoI shall be preserved and packaged by the Contractor to provide physical and mechanical protection, multiple handling, shipment by any mode, and allow for the DSESTS to be placed into storage for a period of one year in an enclosed environmentally controlled facility and suitable for redistribution without additional repackaging. Container closure shall be in accordance with container specification selected by Contractor.

1.9.2 Required software, technical data, and reports delivered under this contract shall be preserved and packaged to deter theft and assure safe arrival at destination without damage to contents. All data deliverables shall be in English unless otherwise specified in this contract.

1.9.3 All Non-manufactured wood used in packaging shall be heat treated to a core temperature of 56 degrees Celsius for a minimum of 30 minutes. Box, pallet, dunnage, and wood used as inner packaging made of non-manufactured wood shall be heat-treated. The box, pallet, dunnage manufacturer, and the manufacturer of wood used as inner packaging shall be accredited by the board of review of the American Lumber Standard Committee. The box, pallet, dunnage manufacturer, and the manufacturer of wood used as inner packaging shall ensure traceability to the original source of heat treatment. All non-manufactured wood products used for shipment to OCONUS locations shall conform to the International Plant Protection Convention International Phytosanitary Measure-15 (ISPM-15).

1.9.4 For each hazardous material item shipped under this contract, a copy of the Material Safety Data Sheet shall be placed into a sealed pouch and attached to the outside surface area of the unit container and intermediate container containing the prescribed hazardous material item(s).

1.10 MARKING:

1.10.1 The M1A1SA GoI DSESTS shall be marked in accordance with MIL-STD- 129P (4).

1.10.2 All software, technical data, and reports referenced in the SOW shall be identified by the prime contract number, name and address of the prime Contractor, and where applicable, the name and address of the subcontractor generating the data.

1.10.3 Marking of Wood Packaging Materials. Each box, pallet, and dunnage shall be marked to show the conformance to the ISPM-15.

1.10.4 Notwithstanding other requirements in this contract with respect to marking of shipments, all shipments moving through air or water terminals to destinations outside the U.S.A. will be marked in accordance with the requirements of DOD 4500.9-R, Part 2 Military Standard Transportation and Movement Procedures , and MIL-STD-129P (4), Military Standard Marking for Shipment and Storage. The Contractor agrees to use USG-supplied DD Forms 1387 (Military Shipment Labels) or DD Forms 1387-1 (Military Shipping Tags) for such shipments, as appropriate per the guidance in MIL-STD-129P (4), and agrees to comply with shipping and marking instructions issued by the Administrative Contracting Officer. The proper marking of export shipments as discussed herein must be accomplished in conjunction with the requirements of FAR 52.247-52, CLEARANCE AND DOCUMENTATION REQUIREMENTS--SHIPMENTS TO DOD AIR OR WATER TERMINAL TRANSSHIPMENT POINTS.

1.11 DEFINITIONS:

1.11.1 Direct Support Electrical System Test Sets (DSESTS) - A microprocessor based automatic test system, which provides troubleshooting capability for weapon systems. The modular design permits user groups to select only the necessary equipment elements to support unique vehicle test requirements.

1.11.2 Automatic Test Equipment (ATE) - The equipment used in troubleshooting the LRUs.

1.11.3 Interconnecting Device - provides the mechanical and electrical connection and signal conditioning, if required, between the ATE and LRU.

1.11.4 Line Replaceable Unit - a major box or enclosure of a subsystem interconnected by external cables and connectors.

1.11.5 Shop Replaceable Unit - includes the sub-components that make up the LRU.

1.11.6 Component - a part, resistor, transistor, or integrated circuit mounted on a circuit board or other modular assembly.

1.11.7 Go-Chain Run - a complete test cycle performed on the test program set to verify that it accepts functionally good LRUs.

1.11.8 Assembly - a collection, grouping or set of parts, sub-assemblies or components brought/joined together to perform a specific function. An assembly forms a complete unit, end-item, structure, or other article/item, e.g., sub-assembly, component system, kit or system group/unit.

1.11.9 Test Program Set (TPS) - a TPS consists of the particular software, hardware, and documentation that are used in conjunction with ATE to detect and isolate failures within an LRU. It shall include the Test Program (TP) on a storage media such as CD, interconnecting device and accessories, and assorted documentation. The TPs shall be structured to provide the total interface between the LRU and the peculiar hardware which will provide for LRU performance verification and fault detection and isolation to the levels specified herein.

1.11.10 Test Set - includes the software and hardware developed for the M1A1.

(2) Cleanliness: Items shall be free of dirt and other contaminants which would contribute to the deterioration of the item or which would require cleaning by the customer prior to use. Coatings and preservatives applied to the item for protection are not considered contaminants.

(3) Preservation: Items susceptible to corrosion or deterioration shall be provided protection by means of preservative coatings, volatile corrosion inhibitors, desiccants, waterproof and/or watervaporproof barriers.

(4) Cushioning: Items requiring protection from physical and mechanical damage (e.g. fragile, sensitive, material critical) or which could cause physical damage to other items, shall be protected by wrapping, cushioning, pack compartmentalization, or other means to mitigate shock and vibration to prevent damage during handling and shipment.

(b) Unit Package: A unit package shall be so designed and constructed that it will contain the contents with no damage to the item(s), and with minimal damage to the unit pack during shipment and storage in the shipping container, and will allow subsequent handling. The outermost component of a unit package shall be a container such as a sealed bag, carton or box. Unit packs shall be designed to conserve weight and cube while retaining the protection required and enhancing standardization.

(c) Unit Package Quantity: Unless otherwise specified, the unit package quantity shall be one each part, set, assembly, kit, etc.

The standardized EPC\TM\ data consists of an EPC\TM\ (or EPC\TM\ identifier) that uniquely identifies an individual object, as well as an optional filter value when judged to be necessary to enable effective and efficient reading of the EPC\TM\ tags. In addition to this standardized data, certain classes of EPC\TM\ tags will allow user-defined data. The EPC\TM\ Tag Data Standards will define the length and position of this data, without defining its content.

"EPCglobal" means a subscriber-driven organization comprised of industry leaders and organizations focused on creating global standards for the adoption of passive RFID technology.

"Exterior container" means a MIL-STD-129 defined container, bundle, or assembly that is sufficient by reason of material, design, and construction to protect unit packs and intermediate containers and their contents during shipment and storage. It can be a unit pack or a container with a combination of unit packs or intermediate containers. An exterior container may or may not be used as a shipping container.

"Palletized unit load" means a MIL-STD-129 defined quantity of items, packed or unpacked, arranged on a pallet in a specified manner and secured, strapped, or fastened on the pallet so that the whole palletized load is handled as a single unit. A palletized or skidded load is not considered to be a shipping container. A loaded 463L System pallet is not considered to be a palletized unit load. Refer to the Defense Transportation Regulation, DoD 4500.9-R, Part II, Chapter 203, for marking of 463L System pallets.

"Passive RFID tag" means a tag that reflects energy from the reader/interrogator or that receives and temporarily stores a small amount of energy from the reader/interrogator signal in order to generate the tag response. The only acceptable tags are EPC Class 1 passive RFID tags that meet the EPCglobal\TM\ Class 1 Generation 2 standard.

"Radio frequency identification (RFID)" means an automatic identification and data capture technology comprising one or more reader/interrogators and one or more radio frequency transponders in which data transfer is achieved by means of suitably modulated inductive or radiating electromagnetic carriers.

"Shipping container" means a MIL-STD-129 defined exterior container that meets carrier regulations and is of sufficient strength, by reason of material, design, and construction, to be shipped safely without further packing (e.g., wooden boxes or crates, fiber and

metal drums, and corrugated and solid fiberboard boxes).

(ii) Are being shipped to one of the locations listed at <http://www.acq.osd.mil/log/rfid/> or to--

(A) A location outside the contiguous United States when the shipment has been assigned Transportation Priority 1, or to--

(B) The following location(s) deemed necessary by the requiring activity:

(2) The following are excluded from the requirements of paragraph (b)(1) of this clause:

(1) Ensure that the data encoded on each passive RFID tag are globally unique (i.e., the tag ID is never repeated across two or more RFID tags) and conforms to the requirements in paragraph (d) of this clause;

(3) Ensure that the passive tag is affixed at the appropriate location on the specific level of packaging, in accordance with MIL-STD-129 (Section 4.9.2) tag placement specifications.

(5) Government Furnished Equipment (GFE/Materials (GFM): Federal Acquisition Regulation (FAR) clause 52.245-1 governs and applies to any issues regarding GFE/GFM or Government Furnished Property (GFP).

(6) Contractor Personal Property: The contractor is advised that all personal property left on the respective installation after the date of departure of said premises, shall be sold or otherwise disposed of, as follows:

(i) A request for the return of the property will be honored, if feasible, and if received before the expiration of the period of time allowed to vacate the installation.

(ii) If abandoned property is left on the respective installation, contractual remedies may be enforced against the contractor, (See paragraph (b) of this clause for potential contractual remedies}. Additionally, even if the contractor waives its interest to all abandoned personal property, the contractor may still be liable for all costs incurred by the USG to remove or dispose of the abandoned property.

(iii) The contractor hereby authorizes the USG authority to dispose of any and all abandoned personal property in any manner the USG may deem suitable and hereby releases and discharges the USG and its agents from any and all claims and demands whatsoever that could otherwise be asserted because of the disposition of said abandoned personal property.

(7) Synchronized Pre-deployment Operational Tracker (SPOT): The prime contractor is responsible to close out the deployment of personnel, including subcontractor employees at all tiers, at the end of the person's employment or at the end of the contract

completion period and to release the personnel from the prime contractor's company information as loaded in the SPOT database. The release of employee information must be accomplished no more than 30 calendar days after the termination of their employment or the end of the contract completion date, whichever occurs sooner.

(8) Accountability of Prime and Subcontractor Personnel: Whether specifically written into the contract or not, it is the expectation of the USG that for any persons brought into the IJOA for the sole purposes of performing work on USG contracts, contract employers will return employees to their point of origin/home country once the contract is completed or their employment is terminated for any reason. If the prime contractor fails to re-deploy an employee (or subcontractor employee) at any tier, or fails to confiscate badging, terminate an LOA, or visa after an employee departs to another employer, the USG shall notify the applicable U.S. Embassy to take appropriate action. If the employee has sought employment under another contract, the gaining employer will be responsible for repatriation upon termination. Failure by the prime contractor to re-deploy its' personnel, including subcontractor personnel at any tier, at the end of the contract completion date, could result in negative past performance ratings and, depending on the severity of the situation, possible proceedings place the contractor on the Excluded Parties List System (EPLS) and not be allowed to propose on future USG contracts anywhere in the world.

(9) Personnel Recovery: Any DoD contractor with unaccounted for employees shall follow the instructions in the "Contractor Accountability and Personnel Recovery" Clause 952.225-0018. The contractor may use the Base Defense Operations Center (BDOC) or the installation force protection officer as a resource to track or research employees last known location and/or to view LOA's.

(b) The Servicing Agency and external agencies will utilize all available contracting remedies to guarantee compliance with demobilization requirements. Such actions include, but are not limited to withholding payment, issuing a cure notice, issuing a negative Contractor Performance Assessment Reporting System (CPARS) evaluation, reduction of award fee, debarment, reimbursement of USC expenses, and/or any other legal remedy available to a Contracting Officer. The USG reserves the right to withhold payment from the prime contractor not in compliance with the above procedures included herein. Additionally, the Contracting Officer shall document all unresolved contractor compliance issues in CPARS, which shall have an adverse past performance affect on future contracts with the USG, anywhere in the world.

(C3)

(a) Contract performance may require work in dangerous or austere conditions. Except as otherwise provided in the contract, the contractor accepts the risks associated with required contract performance in such operations.

(1) Unaccounted Personnel: It is the expectation of the USG that any contractor brought into Iraq for the sole purposes of performance of work on a USG contract must be accounted for at all times by their respective employers. Additionally, contractors who maintain living quarters on an Office of Security Cooperation Iraq (OSC.I) site shall verify the location of each of its employees' living quarters a minimum of once a month. If a DoD contracted employee becomes missing and evidence does not indicate foul play, a Personnel Recovery (PR) event is NOT automatically triggered. Such an event will be treated as an accountability battle drill by the employer's chain of command or civilian equivalent.

(2) Contractor Responsibilities: The contractor is responsible to take all necessary steps to locate and investigate the unaccounted for employee(s) whereabouts to the maximum extent practicable. To assist in this process, contractors may use the Base Defense Operations Center (BDOC) at their OSC-I site as a resource to track or research employee's last known location and/or to view Synchronized Pre-deployment Operational Tracker (SPOT) generated letters of authorization (LOA's). All missing personnel will immediately be reported to the Installation Manager and Force Protection Offer (FPO), and the OSC-I BDOC for the installation they are located at.

(3) Contractor Provided Information: If it is determined that a potential criminal act has occurred, the OSC-I FPO will attempt to validate the missing person's identity through the employer. The contractor shall provide the information to the FPO within 12 hours of request. The required information the contractor should keep on file includes but is not limited to: copy of the individuals SPOT generated LOA, copy of passport and visas, housing information of where the individual resides such as room number and location, DD Form 93, Record of Emergency Data, copy of badging, and contact information for known friends or associates.

(b) If OSC-I FPO determines through investigation that the unaccounted personnel have voluntarily left the installation either seeking employment with another contractor or other non-mission related reasons, FPO will notify the contractor. The contractor shall ensure that all government-related documents such as LOA's, visas, Common Access Card (CAC), etc. are terminated/reconciled appropriately

(a) Invoicing.

(1) The Government will make payments to the Contractor when requested as work progresses, but (except for small business concerns) not more often than once every 2 weeks, in amounts determined to be allowable by the Contracting Officer in accordance with Federal Acquisition Regulation (FAR) Subpart 31.2 in effect on the date of this contract and the terms of this contract. The Contractor may submit to an authorized representative of the Contracting Officer, in such form and reasonable detail as the representative may require, an invoice or voucher supported by a statement of the claimed allowable cost for performing this contract.

(2) Contract financing payments are not subject to the interest penalty provisions of the Prompt Payment Act. Interim payments made prior to the final payment under the contract are contract financing payments, except interim payments if this contract contains Alternate I to the clause at 52.232-25.

(3) The designated payment office will make interim payments for contract financing on the 30th day after the designated billing office receives a proper payment request. In the event that the Government requires an audit or other review of a specific payment request to ensure compliance with the terms and conditions of the contract, the designated payment office is not compelled to make payment by the specified due date.

(b) Reimbursing costs.

(1) For the purpose of reimbursing allowable costs (except as provided in subparagraph (b)(2) of this clause, with respect to pension, deferred profit sharing, and employee stock ownership plan contributions), the term costs includes only --

(i) Those recorded costs that, at the time of the request for reimbursement, the Contractor has paid by cash, check, or other form of actual payment for items or services purchased directly for the contract;

(ii) When the Contractor is not delinquent in paying costs of contract performance in the ordinary course of business, costs incurred, but not necessarily paid, for --

(A) Supplies and services purchased directly for the contract and associated financing payments to subcontractors, provided payments determined due will be made

(1) In accordance with the terms and conditions of a subcontract or invoice; and

(2) Ordinarily within 30 days of the submission of the Contractors payment request to the Government;

(B) Materials issued from the Contractors inventory and placed in the production process for use on the contract;

(C) Direct labor;

(D) Direct travel;

(E) Other direct in-house costs; and

(F) Properly allocable and allowable indirect costs, as shown in the records maintained by the Contractor for purposes of obtaining reimbursement under Government contracts; and

(iii) The amount of financing payments that have been paid by cash, check or other form of payment to subcontractors.

(2) Accrued costs of Contractor contributions under employee pension plans shall be excluded until actually paid unless

(i) The Contractors practice is to make contributions to the retirement fund quarterly or more frequently; and

(ii) The contribution does not remain unpaid 30 days after the end of the applicable quarter or shorter payment period (any contribution remaining unpaid shall be excluded from the Contractors indirect costs for payment purposes).

(3) Notwithstanding the audit and adjustment of invoices or vouchers under paragraph (g) of this clause, allowable indirect costs under this contract shall be obtained by applying indirect cost rates established in accordance with paragraph (d) of this clause.

(4) Any statements in specifications or other documents incorporated in this contract by reference designating performance of services or furnishing of materials at the Contractors expense or at no cost to the Government shall be disregarded for purposes of cost-reimbursement under this clause.

(c) Small business concerns. A small business concern may receive more frequent payments than every 2 weeks.

(d) Final indirect cost rates.

(1) Final annual indirect cost rates and the appropriate bases shall be established in accordance with Subpart 42.7 of the Federal Acquisition Regulation (FAR) in effect for the period covered by the indirect cost rate proposal.

(2)(i) The Contractor shall submit an adequate final indirect cost rate proposal to the Contracting Officer (or cognizant Federal agency official) and auditor within the 6-month period following the expiration of each of its fiscal years. Reasonable extensions, for exceptional circumstances only, may be requested in writing by the Contractor and granted in writing by the Contracting Officer. The Contractor shall support its proposal with adequate supporting data.

(ii) The proposed rates shall be based on the Contractors actual cost experience for that period. The appropriate Government representative and the Contractor shall establish the final indirect cost rates as promptly as practical after receipt of the Contractors proposal.

(iii) An adequate indirect cost rate proposal shall include the following data unless otherwise specified by the cognizant Federal agency official:

(A) Summary of all claimed indirect expense rates, including pool, base, and calculated indirect rate.

(B) General and Administrative expenses (final indirect cost pool). Schedule of claimed expenses by element of cost as identified in accounting records (Chart of Accounts).

(C) Overhead expenses (final indirect cost pool). Schedule of claimed expenses by element of cost as identified in accounting records (Chart of Accounts) for each final indirect cost pool.

(D) Occupancy expenses (intermediate indirect cost pool). Schedule of claimed expenses by element of cost as identified in accounting records (Chart of Accounts) and expense reallocation to final indirect cost pools.

(E) Claimed allocation bases, by element of cost, used to distribute indirect costs.

(F) Facilities capital cost of money factors computation.

(G) Reconciliation of books of account (i.e., General Ledger) and claimed direct costs by major cost element.

(H) Schedule of direct costs by contract and subcontract and indirect expense applied at claimed rates, as well as a subsidiary schedule of Government participation percentages in each of the allocation base amounts.

Name of Offeror or Contractor:

(I) Schedule of cumulative direct and indirect costs claimed and billed by contract and subcontract.

(J) Subcontract information. Listing of subcontracts awarded to companies for which the contractor is the prime or upper-tier contractor (include prime and subcontract numbers; subcontract value and award type; amount claimed during the fiscal year; and the subcontractor name, address, and point of contact information).

(K) Summary of each time-and-materials and labor-hour contract information, including labor categories, labor rates, hours, and amounts; direct materials; other direct costs; and, indirect expense applied at claimed rates.

(L) Reconciliation of total payroll per IRS form 941 to total labor costs distribution.

(M) Listing of decisions/agreements/approvals and description of accounting/organizational changes.

(N) Certificate of final indirect costs (see 52.242-4, Certification of Final Indirect Costs).

(O) Contract closing information for contracts physically completed in this fiscal year (include contract number, period of performance, contract ceiling amounts, contract fee computations, level of effort, and indicate if the contract is ready to close).

(iv) The following supplemental information is not required to determine if a proposal is adequate, but may be required during the audit process:

(A) Comparative analysis of indirect expense pools detailed by account to prior fiscal year and budgetary data.

(B) General Organizational information and Executive compensation for the five most highly compensated executives. See 31.205-6(p). Additional salary reference information is available at http://www.whitehouse.gov/omb/procurement_index_exec_comp/.

(C) Identification of prime contracts under which the contractor performs as a subcontractor.

(D) Description of accounting system (excludes contractors required to submit a CAS Disclosure Statement or contractors where the description of the accounting system has not changed from the previous year's submission).

(E) Procedures for identifying and excluding unallowable costs from the costs claimed and billed (excludes contractors where the procedures have not changed from the previous year's submission).

(F) Certified financial statements and other financial data (e.g., trial balance, compilation, review, etc.).

(G) Management letter from outside CPAs concerning any internal control weaknesses.

(H) Actions that have been and/or will be implemented to correct the weaknesses described in the management letter from subparagraph (G) of this section.

(I) List of all internal audit reports issued since the last disclosure of internal audit reports to the Government.

(J) Annual internal audit plan of scheduled audits to be performed in the fiscal year when the final indirect cost rate submission is made.

(K) Federal and State income tax returns.

(L) Securities and Exchange Commission 10-K annual report.

(M) Minutes from board of directors meetings.

(N) Listing of delay claims and termination claims submitted which contain costs relating to the subject fiscal year.

(O) Contract briefings, which generally include a synopsis of all pertinent contract provisions, such as: Contract type, contract amount, product or service(s) to be provided, contract performance period, rate ceilings, advance approval requirements, pre-contract cost allowability limitations, and billing limitations.

(v) The Contractor shall update the billings on all contracts to reflect the final settled rates and update the schedule of cumulative direct and indirect costs claimed and billed, as required in paragraph (d)(2)(iii)(I) of this section, within 60 days after settlement of final indirect cost rates.

Name of Offeror or Contractor:

(3) The Contractor and the appropriate Government representative shall execute a written understanding setting forth the final indirect cost rates. The understanding shall specify

- (i) the agreed-upon final annual indirect cost rates,
- (ii) the bases to which the rates apply,
- (iii) the periods for which the rates apply,
- (iv) any specific indirect cost items treated as direct costs in the settlement, and
- (v) the affected contract and/or subcontract, identifying any with advance agreements or special terms and the applicable rates.

The understanding shall not change any monetary ceiling, contract obligation, or specific cost allowance or disallowance provided for in this contract. The understanding is incorporated into this contract upon execution.

(4) Failure by the parties to agree on a final annual indirect cost rate shall be a dispute within the meaning of the Disputes clause.

(5) Within 120 days (or longer period if approved in writing by the Contracting Officer) after settlement of the final annual indirect cost rates for all years of a physically complete contract, Contractor shall submit a completion invoice or voucher to reflect the settled amounts and rates. The completion invoice or voucher shall include settled subcontract amounts and rates. The prime contractor is responsible for settling subcontractor amounts and rates included in the completion invoice or voucher and providing status of subcontractor audits to the contracting officer upon request.

(6)(i) If the Contractor fails to submit a completion invoice or voucher within the time specified in paragraph (d)(5) of this clause, the Contracting Officer may--

- (A) Determine the amounts due to the Contractor under the contract; and
- (B) Record this determination in a unilateral modification to the contract.

(ii) This determination constitutes the final decision of the Contracting Officer in accordance with the Disputes clause.

(e) Billing rates. Until final annual indirect cost rates are established for any period, the Government shall reimburse the Contractor at billing rates established by the Contracting Officer or by an authorized representative (the cognizant auditor), subject to adjustment when the final rates are established. These billing rates --

(1) Shall be the anticipated final rates; and

(2) May be prospectively or retroactively revised by mutual agreement, at either party's request, to prevent substantial overpayment or underpayment.

(f) Quick-closeout procedures. Quick-closeout procedures are applicable when the conditions in FAR 42.708(a) are satisfied.

(g) Audit. At any time or times before final payment, the Contracting Officer may have the Contractor's invoices or vouchers and statements of cost audited. Any payment may be --

- (1) Reduced by amounts found by the Contracting Officer not to constitute allowable costs; or
- (2) Adjusted for prior overpayments or underpayments.

(h) Final payment.

(1) Upon approval of a completion invoice or voucher submitted by the Contractor in accordance with paragraph (d)(5) of this clause, and upon the Contractor's compliance with all terms of this contract, the Government shall promptly pay any balance of allowable costs and that part of the fee (if any) not previously paid.

(2) The Contractor shall pay to the Government any refunds, rebates, credits, or other amounts (including interest, if any) accruing to or received by the Contractor or any assignee under this contract, to the extent that those amounts are properly allocable to costs for which the Contractor has been reimbursed by the Government. Reasonable expenses incurred by the Contractor for securing refunds, rebates, credits, or other amounts shall be allowable costs if approved by the Contracting Officer. Before final payment under this contract, the Contractor and each assignee whose assignment is in effect at the time of final payment shall execute and deliver --

- (i) An assignment to the Government, in form and substance satisfactory to the Contracting Officer, of refunds, rebates, credits, or

other amounts (including interest, if any) properly allocable to costs for which the Contractor has been reimbursed by the Government under this contract; and

(ii) A release discharging the Government, its officers, agents, and employees from all liabilities, obligations, and claims arising out of or under this contract, except --

(A) Specified claims stated in exact amounts, or in estimated amounts when the exact amounts are not known;

PROGRESS PAYMENTS

APR/2012

The Government will make progress payments to the Contractor when requested as work progresses, but not more frequently than monthly in amounts of \$2,500 or more approved by the Contracting Officer, under the following conditions:

(a) Computation of amounts.

(1) Unless the Contractor requests a smaller amount, the Government will compute each progress payment as 80 percent of the Contractors total costs incurred under this contract whether or not actually paid, plus financing payments to subcontractors (see paragraph (j) of this clause), less the sum of all previous progress payments made by the Government under this contract. The Contracting Officer will consider cost of money that would be allowable under FAR 31.205-10 as an incurred cost for progress payment purposes.

(2) The amount of financing and other payments for supplies and services purchased directly for the contract are limited to the amounts that have been paid by cash, check, or other forms of payment, or that are determined due will be paid to subcontractors--

(i) In accordance with the terms and conditions of a subcontract of invoice; and

(ii) Ordinarily within 30 days of the submission of the Contractors payment request to the Government.

(3) The Government will exclude accrued costs of Contractor contributions under employee pension plans until actually paid unless--

(i) The Contractors practice is to make contributions to the retirement fund quarterly or more frequently; and

(ii) The contribution does not remain unpaid 30 days after the end of the applicable quarter or shorter payment period (any contribution remaining unpaid shall be excluded from the Contractors total costs for progress payments until paid).

(4) The Contractor shall not include the following in total costs for progress payment purposes in paragraph (a)(1) of this clause:

(i) Costs that are not reasonable, allocable to this contract, and consistent with sound and generally accepted accounting principles and practices.

(ii) Costs incurred by subcontractors or suppliers.

(iii) Costs ordinarily capitalized and subject to depreciation or amortization except for the properly depreciated or amortized portion of such costs.

(iv) Payments made or amounts payable to the subcontractors or suppliers, except for--

(A) completed work, including partial deliveries, to which the Contractor has acquired title; and

(B) Work under cost-reimbursement or time-and-material subcontracts to which the Contractor has acquired title.

Name of Offeror or Contractor:

(5) The amount of unliquidated progress payments may exceed neither (i) the progress payments made against incomplete work (including allowable unliquidated progress payments to subcontractors) nor (ii) the value, for progress payment purposes, of the incomplete work. Incomplete work shall be considered to be the supplies and services required by this contract, for which delivery and invoicing by the Contractor and acceptance by the Government are incomplete.

(6) The total amount of progress payments shall not exceed 80 percent of the total contract price.

(7) If a progress payment or the unliquidated progress payments exceed the amounts permitted by subparagraphs (a)(4) or (a)(5) above, the Contractor shall repay the amount of such excess to the Government on demand.

(8) Notwithstanding any other terms of the contract, the Contractor agrees not to request progress payments in dollar amounts of less than \$2,500. The Contracting Officer may make exceptions.

(9) The costs applicable to items delivered, invoiced, and accepted shall not include costs in excess of the contract price of the items.

(b) Liquidation. Except as provided in the Termination for Convenience of the Government clause, all progress payments shall be liquidated by deducting from any payment under this contract, other than advance or progress payments, the unliquidated progress payments, or 80 percent of the amount invoiced, whichever is less. The Contractor shall repay to the Government any amounts required by a retroactive price reduction, after computing liquidations and payments on past invoices at the reduced prices and adjusting the unliquidated progress payments accordingly. The Government reserves the right to unilaterally change from the ordinary liquidation rate to an alternate rate when deemed appropriate for proper contract financing.

(c) Reduction or suspension. The Contracting Officer may reduce or suspend progress payments, increase the rate of liquidation, or take a combination of these actions, after finding on substantial evidence any of the following conditions:

(1) The Contractor failed to comply with any material requirement of this contract (which includes paragraphs (f) and (g) below).

(2) Performance of this contract is endangered by the Contractors --

- (i) Failure to make progress; or
- (ii) Unsatisfactory financial condition.

(3) Inventory allocated to this contract substantially exceeds reasonable requirements.

(4) The Contractor is delinquent in payment of the costs of performing this contract in the ordinary course of business.

(5) The fair value of the undelivered work is less than the amount of unliquidated progress payments for that work.

(6) The Contractor is realizing less profit than that reflected in the establishment of any alternate liquidation rate in paragraph (b) above, and that rate is less than the progress payment rate stated in subparagraph (a)(1) above.

(d) Title.

(1) Title to the property described in this paragraph (d) shall vest in the Government. Vestiture shall be immediately upon the date of this contract, for property acquired or produced before that date. Otherwise, vestiture shall occur when the property is or should have been allocable or properly chargeable to this contract.

(2) Property, as used in this clause, includes all of the below-described items acquired or produced by the Contractor that are or should be allocable or properly chargeable to this contract under sound and generally accepted accounting principles and practices.

(i) Parts, materials, inventories, and work in process;

(ii) Special tooling and special test equipment to which the Government is to acquire title;

(iii) Nondurable (i.e., noncapital) tools, jigs, dies, fixtures, molds, patterns, taps, gauges, test equipment, and other similar manufacturing aids, title to which would not be obtained as special tooling under subparagraph (ii) above; and

(iv) Drawings and technical data, to the extent the Contractor or subcontractors are required to deliver them to the Government by other clauses of this contract.

(3) Although title to property is in the Government under this clause, other applicable clauses of this contract; e.g., the termination clauses, shall determine the handling and disposition of the property.

(4) The Contractor may sell any scrap resulting from production under this contract without requesting the Contracting Officers

approval, but the proceeds shall be credited against the costs of performance.

(5) To acquire for its own use or dispose of property to which title is vested in the Government under this clause, the Contractor must obtain the Contracting Officers advance approval of the action and the terms. The Contractor shall

(i) exclude the allocable costs of the property from the costs of contract performance, and

(ii) repay to the Government any amount of unliquidated progress payments allocable to the property. Repayment may be by cash or credit memorandum.

(6) When the Contractor completes all of the obligations under this contract, including liquidation of all progress payments, title shall vest in the Contractor for all property (or the proceeds thereof) not --

(i) Delivered to, and accepted by, the Government under this contract; or

(ii) Incorporated in supplies delivered to, and accepted by, the Government under this contract and to which title is vested in the Government under this clause.

(7) The terms of this contract concerning liability for Government-furnished property shall not apply to property to which the Government acquired title solely under this clause.

(e) Risk of loss. Before delivery to and acceptance by the Government, the Contractor shall bear the risk of loss for property, the title to which vests in the Government under this clause, except to the extent the Government expressly assumes the risk. The Contractor shall repay the Government an amount equal to the unliquidated progress payments that are based on costs allocable to property that is lost (see 45.101).

(f) Control of costs and property. The Contractor shall maintain an accounting system and controls adequate for the proper administration of this clause.

(g) Reports, forms, and access to records.

(1) The Contractor shall promptly furnish reports, certificates, financial statements, and other pertinent information (including estimates to complete) reasonably requested by the Contracting Officer for the administration of this clause. Also, the Contractor shall give the Government reasonable opportunity to examine and verify the Contractor's books, records, and accounts.

(2) The Contractor shall furnish estimates to complete that have been developed or updated within six months of the date of the progress payment request. The estimates to complete shall represent the Contractor's best estimate of total costs to complete all remaining contract work required under the contract. The estimates shall include sufficient detail to permit Government verification.

(3) Each Contractor request for progress payment shall:

(i) Be submitted on Standard Form 1443, Contractor's Request for Progress Payment, or the electronic equivalent as required by agency regulations, in accordance with the form instructions and the contract terms; and

(ii) Include any additional supporting documentation requested by the Contracting Officer.

(h) Special terms regarding default. If this contract is terminated under the Default clause,

(i) the Contractor shall, on demand, repay to the Government the amount of unliquidated progress payments and

(ii) title shall vest in the Contractor, on full liquidation of progress payments, for all property for which the Government elects not to require delivery under the Default clause. The Government shall be liable for no payment except as provided by the Default clause.

(i) Reservations of rights.

(1) No payment or vesting of title under this clause shall --

(i) Excuse the Contractor from performance of obligations under this contract; or

(ii) Constitute a waiver of any of the rights or remedies of the parties under the contract.

(2) The Governments rights and remedies under this clause --

(i) Shall not be exclusive but rather shall be in addition to any other rights and remedies provided by law or this contract; and

(ii) Shall not be affected by delayed, partial, or omitted exercise of any right, remedy, power, or privilege, nor shall such exercise or any single exercise preclude or impair any further exercise under this clause or the exercise of any other right, power, or privilege of the Government.

(j) Financing payments to subcontractors. The financing payments to subcontractors mentioned in paragraphs (a)(1) and (a)(2) of this clause shall be all financing payments to subcontractors or divisions, if the following conditions are met:

(1) The amounts included are limited to --

(i) The unliquidated remainder of financing payments made; plus

(ii) Any unpaid subcontractor requests for financing payments.

(2) The subcontract or interdivisional order is expected to involve a minimum of approximately 6 months between the beginning of work and the first delivery, or, if the subcontractor is a small business concern, 4 months.

(3) If the financing payments are in the form or progress payments, the terms of the subcontract or interdivisional order concerning progress payments --

(i) Are substantially similar to the terms of the clause for any subcontractor that is a large business concern, or that clause with its Alternate I for any subcontractor that is a small business concern;

(ii) Are at least as favorable to the Government as the terms of this clause;

(iii) Are not more favorable to the subcontractor or division than the terms of this clause are to the Contractor;

(iv) Are in conformance with the requirements of FAR 32.504(e); and

(v) Subordinate all subcontractor rights concerning property to which the Government has title under the subcontract to the Government's right to require delivery of the property to the Government if --

(A) The Contractor defaults; or

(B) The subcontractor becomes bankrupt or insolvent.

(4) If the financing payments are in the form of performance-based payments, the terms of the subcontract or interdivisional order concerning payments--

(i) Are substantially similar to the Performance-Based Payments clause at FAR 52.232-32 and meet the criteria for, and definition of, performance-based payments in FAR Part 32;

(ii) Are in conformance with the requirements of FAR 32.504(f); and

(iii) Subordinate all subcontractor rights concerning property to which the Government has title under the subcontract to the Government's right to require delivery of the property to the Government if--

(A) The Contractor defaults; or

(B) The subcontractor becomes bankrupt or insolvent.

(5) If the financing payments are in the form of commercial item financing payments, the terms of the subcontract or interdivisional order concerning payments

(i) Are constructed in accordance with FAR 32.206(c) and included in a subcontract for a commercial item purchase that meets the definition and standards for acquisition of commercial items in FAR Part 2 and 12;

(ii) Are in conformance with the requirements of FAR 32.504(g); and

(iii) Subordinate all subcontractor rights concerning property to which the Government has title under the subcontract to the Government's right to require delivery of the property to the Government if--

(A) The Contractor defaults; or

(B) The subcontractor becomes bankrupt or insolvent.

(6) If financing is in the form of progress payments, the progress payment rate in the subcontract is the customary rate used by the contracting agency, depending on whether the subcontractor is or is not a small business concern.

(7) Concerning any proceeds received by the Government for property to which title has vested in the Government under the subcontract terms, the parties agree that the proceeds shall be applied to reducing any unliquidated financing payments by the Government to the Contractor under this contract.

(8) If no unliquidated financing payments to the Contractor remain, but there are unliquidated financing payments that the Contractor has made to any subcontractor, the Contractor shall be subrogated to all the rights the Government obtained through the terms required by this clause to be in any subcontract, as if all such rights had been assigned and transferred to the Contractor.

(k) Limitations on undefinitized contract actions. (4) The written decision will be binding on the Army Materiel Command and its contracting activities.

(5) For good cause shown, the HQAMC protest decision authority may grant extensions of time for filing the administrative report and for the issuance of the written decision. When such an extension is granted, the protestor and all interested parties shall be notified within one working day of the decision to grant the extension.

(h) Effect of Protest on Award and Performance:

(1) Protests before award: When a protest is filed with HQAMC prior to award, a contract may not be awarded unless authorized by the HQAMC director of contracting, in accordance with FAR 33.103(f).

(2) Protests after award: When a protest is filed with HQAMC within 10 calendar days after award, or within five calendar days of debriefing for any debriefing that when requested was required by FAR 15.506, the contracting officer shall suspend performance. The HQAMC director of contracting may authorize contract performance, notwithstanding the protest, upon a written finding that:

-- contract performance will be in the best interests of the United States; or

-- urgent and compelling circumstances that significantly affect the interests of the United States will not permit waiting for a decision from the HQAMC protest decision authority.

(i) Remedies:

The HQAMC protest decision authority may grant any one or combination of the following remedies:

- a. terminate the contract;
- b. re-compete the requirement;
- c. issue a new solicitation;
- d. refrain from exercising options under the contract;
- e. award a contract consistent with statute and regulation;
- f. pay appropriate costs as stated in FAR 33.102(b)(2);
- g. such other remedies as HQAMC protest decision authority determines necessary to correct a defect.
