STATEMENT OF WORK
REPAIR OF
M25 STABILIZED BINOCULAR

C.1. OVERVIEW.

This Statement of Work (SOW) is for the repair of Government owned Binocular, Stabilized, M25 (Part No. 12961237) (Drawing # 93143-100-14) not under original product warranty.

Nomenclature: Binocular, stabilized, M25

Part No. 12961237 (Drawing # 93143-100-14) (Attachment 0001)

Contractor shall be responsible for determining the supplies necessary to perform this statement of work and provide them accordingly.

C.2. RECEIPT.

C.2.1. Upon receipt of Government owned M25 Binocular units, Contractor shall notify via email message, the Defense Contract Management Agency (DCMA) Quality Assurance Representative (QAR), as well as the Contracting Officers Representative (COR), the Procuring Contracting Officer (PCO), and the Product Quality Manger (PQM) of the incoming receipt.

C.3 EVALUATION.

C.3.2. Contractor shall visually evaluate each M25 Binocular unit to determine M25 Binocular unit failures and specific repair work required. Once units have been evaluated to determine failures and work requirements, Contractor shall perform the tests listed in section C.6. Testing to verify what needs to be repaired. Contractor shall maintain records of M25 Binocular unit evaluations and testing, including test results, which shall be made available for Government review.

C.3.3. Contractor shall also perform an initial optical performance evaluation of the M25 binocular by viewing a uniformly illuminated field having a brightness of approximately 300 apparent foot-lamberts per MIL-PRF-13830 paragraph 4.2.10.9. Using only the unaided eye, the observer shall look for any signs of dirt, foreign particles, scratches, dark spots or any defect that appears within the clear aperture and can have a degrading, defined as reduces/obstructs optical clarity (vision) in any way, impact on the image resolution. Any defect determined to be in any of the binoculars eyepieces will be corrected.

C.4. REPORTING.

C.4.1. For each M25 Binocular unit, Contractor shall provide a Repair Categorization Report IAW CDRL A001. The Repair Categorization Report must be delivered to COR, PQM and Contract Specialist within 5 business days upon Government receipt of repaired M25s. Contractor shall provide a detailed report to include the following information:

- Serial Numbers
- Classification
- Date of initial Government acceptance of Unit

C.5. REPAIR.

C.5.1. All M25 Binocular unit(s) shall be repaired, replaced and cleaned to conform to standards per Drawing Number 93143-100-14, Revision GB, dated 22 February 2006, and Purchase Description, Binocular: Stabilized, M25, AR-PD-121, dated 17 Mar 10 (Attachment 0002).

C.5.2. Contractor shall not repair any M25 Stabilized Binocular with a serial number of 20,000 or below. If a unit with a serial number of 20,000 or below is identified, PCO or COR must be notified for disposition instructions.

C.5.3. Contractor shall not replace subassemblies/components that are operable and do not require repair, with the exception of the Battery Cap Assembly. If the Battery Cap Assembly does not meet the current Drawing Number 93143-100-14, Revision GB, dated 22 February 2006: Battery Cap Assembly NSN: 6160-01-486-8248, Part Number: 93143-127, then it shall be replaced regardless of its operability.

C.5.4. Contractor shall replace all damaged markings, identifications, and decals if they are unreadable.

C.5.5. Optic(s) prism(s) on the M25 Binocular system shall be replaced if scratches, delaminating or other optical flaws degrade or deteriorate the performance as specified in paragraph C.3.3.

C.5.6. Contractor shall repair any protective finish damage required to provide protection during field usage, to prevent corrosion, and to ensure structural integrity of the M25 Binocular unit.

C.5.7. Cleaning and Battery Replacement. Contractor shall clean all M25 Binocular units, including the unit case, pouch, and optics. Contractor shall provide new replacement batteries in all M25 Binocular units.

C.6. TESTING.

C.6.1. If any defect is found in the binocular that cannot be removed by external means, the item will undergo a resolution test in accordance with MIL-PRF-13830, paragraph 4.2.5. Any degradation of the resolution that is not in accordance with the M25 Purchase Description shall result in opening up the binocular and performing an internal evaluation as to the effort required to bring it back into conformance. When the binocular is repaired and reassembled, the resolution test will be repeated to verify the repair.

C.6.2. The Contractor shall perform the output amplitude test of AR-PD-121, Paragraph 3.6.1 on all repaired M25 Binocular units, utilizing the analog red dot vibration compensating fixture.

C.6.3. Contractor shall conduct functional testing on all repaired M25 Binocular units pursuant to Attachment 0003, Functional Test and Acceptance Procedures.

The AMC command counsel is designated as the HQAMC protest decision authority. In the absence of the command counsel, the deputy command counsel is designated as the HQAMC protest decision authority.

(e) Time for Filing a Protest:

A HQAMC protest shall be filed in accordance with the timeframes set out in FAR 33.103(e). HQAMC Office Hours are 8:00 AM to 4:30 PM Eastern Standard Time. Time for filing any document expires at 4:30 PM, Eastern Standard Time on the last day on which such filing may be made.

(f) Form of Protest:

HQAMC protest shall include the protestor's name, address and telephone number, including fax number; the solicitation or contract number, identity of the contracting activity and the contracting officer's name; a detailed statement of all legal and factual grounds for protest, including copies of all relevant documents; a request for a ruling; and, a request for relief. All protests must be signed by an authorized representative of the protestor.

- (2) Within 10 working days after the protest is filed, the contracting officer, with the assistance of legal counsel, shall file with the HQAMC Office of Command Counsel, ATTN: AMCCC-PL, an administrative report responsive to the protest. Reports shall be sent by facsimile, over-night mail or hand-delivered, to ensure timely receipt.

- (3) The HQAMC protest decision authority will issue a written decision within 20 working days after the filing of the protest.

- (4) The written decision will be binding on the Army Materiel Command and its contracting activities.

- (5) For good cause shown, the HQAMC protest decision authority may grant extensions of time for filing the administrative report and for the issuance of the written decision. When such an extension is granted, the protestor and all interested parties shall be notified

(h) Effect of Protest on Award and Performance:

(1) Protests before award: When a protest is filed with HQAMC prior to award, a contract may not be awarded unless authorized by the HQAMC director of contracting, in accordance with FAR 33.103(f).

(2) Protests after award: When a protest is filed with HQAMC within 10 calendar days after award, or within five calendar days of debriefing for any debriefing that when requested was required by FAR 15.506, the contracting officer shall suspend performance. The HQAMC director of contracting may authorize contract performance, notwithstanding the protest, upon a written finding that:

-- contract performance will be in the best interests of the United States; or

-- urgent and compelling circumstances that significantly affect the interests of the United States will not permit waiting for a decision from the HQAMC protest decision authority.

(i) Remedies:

The HQAMC protest decision authority may grant any one or combination of the following remedies:

- a. terminate the contract;
- b. re-compete the requirement;
- c. issue a new solicitation;
- d. refrain from exercising options under the contract;
- e. award a contract consistent with statute and regulation;
- f. pay appropriate costs as stated in FAR 33.102(b)(2);
- g. such other remedies as HQAMC protest decision authority determines necessary to correct a defect.

 (TACOM) TOOLING

(a) It is not the intent of the Government to acquire, or to have acquired for its account, any facilities, special test equipment, or special tooling as those terms are defined below. The Government shall under no circumstances reimburse the offeror for the cost of any new facilities, special test equipment, or special tooling as a separate item. An offeror may, however, amortize the cost of any such facilities, special test equipment, or special tooling it may require in the submitted price of the items. Such facilities, special test equipment or special tooling shall not be subject to Government option rights to take title to the same except as specified in the DEFAULT, TERMINATION FOR THE CONVENIENCE OF THE GOVERNMENT, and/or PROGRESS PAYMENT clauses of this contract.

(b) As used in this solicitation/contract, FACILITIES means industrial property (other than material, special tooling, military property, and special test equipment) for production, maintenance, research, development, or test, including real property and rights in it, buildings, structures, improvements, and plant equipment.

(c) As used in this solicitation/contract, SPECIAL TEST EQUIPMENT means either single or multipurpose integrated test units engineered, designed, fabricated, or modified to accomplish special purpose testing in the performance of the contract. Such testing units comprise electrical, electronic, hydraulic, pneumatic, mechanical, or other items or assemblies of equipment, that are mechanically, electrically, or electronically interconnected so as to become a new functional entity, causing the individual item or items to become interdependent and essential in the performance of special purpose testing in the development or production of particular supplies or services. The term SPECIAL TEST EQUIPMENT does not include: (1) material; (2) special tooling; (3) buildings and nonseverable structures (except foundations and similar improvements necessary for the installation of special test equipment); and (4) plant equipment items used for general plant testing purposes.

(d) As used in this solicitation/contract, SPECIAL TOOLING means all jigs, dies, fixtures, molds, patterns, taps, gauges, other equipment and manufacturing aids, and their replacements, which are of such a specialized nature that, without substantial modification or alteration, their use is limited to the development or production of particular supplies or parts of them, or the performance of particular services. The term includes all components of such items, but does not include: (1) material; (2) special test equipment; or (3) buildings, and nonseverable structures (except foundations and similar improvements necessary for the installation of special tooling), general or special machine tools, or similar capital items.
