SECTION C - DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

C-1 STATEMENT OF WORK

The Department of Defense (DoD) ASSIST/ON LINE database located at www.dsp.dla.mil shall be used to determine the revision levels of the military specifications/standards used in the solicitation. The revision level used shall be determined by the date of the revision level at the time of issuance of the solicitation unless amended in the RFP/Contract. See FAR 52.211-2.

C-2 GENERAL SCOPE OF WORK

C-2.1 Contractor shall manufacture, test, and inspect the items in accordance with the Technical Data Package (TDP), associated drawings, patterns, specifications, and standards.

C-3 QUALITY MANAGEMENT

C-3.1 The objectives of these Quality Assurance requirements are to ensure the Contractor's products and processes meet the system performance requirements, and to identify any issues early which might negatively impact the timeliness or performance of the delivered product. The Government reserves the right to audit products and processes, as well as the quality management system, of the Prime Contractor and its subcontractors at any stage of contract performance. The Contractor shall fabricate, test, and deliver T11/MC6s in accordance with this SOW, Contract delivery orders, and delivery schedules. The Contractor shall ensure that the delivered T11/MC6s comply with all of the requirements of the Quality Validation Plan (QVP), Production Process Package (PPP), Contract, and this SOW.

C-3.2 Quality Validation Plan (QVP). The Contractor shall ensure the quality of delivered systems as outlined in the QVP. The Government will incorporate the QVP into the contract at award or modification. The Contractor shall submit the QVP within 10 working days of the request, for government approval, per CDRL A001. Copies should be submitted to PM SCIE Quality Assurance, Contracting Officer, the Contracting Officer Representative, and cognizant DCMA. The QVP shall document the Contractor's approach to ensure all delivered items meet the requirements of the contract and SOW throughout the life of the contract. Once approved, any changes to the QVP require Government concurrence. The Government reserves the right to request and review this data at any time. The plan shall document how process control will be maintained in all areas of operations, for the contractor, sub-contractors, and critical suppliers. Sub-contractors and suppliers of critical component, materials, or processes shall be identified in the quality plan, including names and contact information of key supplier personnel. In the event of end item non-conformance, the contractor shall be responsible for all costs and retests, and reporting required to achieve conformance, unless otherwise directed by the Government. The Government reserves the right to review/audit any suppliers. No review/audit of any sub-contractors or suppliers by the Government will relieve the Contractor of its responsibility for the performance and inspection of the products or services acquired by its suppliers.

C-3.3 Production Process Package (PPP). A PPP shall be prepared by the contractor, validated by DCMA, and submitted for government approval, per the requirements of CDRL A002. The PPP submission should be prepared in conjunction with the First Article build, and is required 10 working days after FAT submission (based on DCMA signed date on DD1222). Copies should be submitted to PM SCIE Quality Assurance, Contracting Officer, the Contracting Officer Representative, and cognizant DCMA. The PPP shall be approved by the Contracting Officer prior to issuance of the FAT Approval Letter. The PPP is to be design specific, and should supplement, not replace, the Quality Validation Plan (QVP). The PPP should identify, at a minimum:

- a) Manufacturer
- b) Contract
- c) Design
- d) Raw materials
- e) Raw material suppliers
- f) Incoming material supplier test data/certifications
- g) Incoming material inspection/testing
- h) Work instructions/procedures and revision of each
- i) Machine set points/specifications
- j) In process inspection processes
- k) End item inspection and test processes
- l) Packaging/shipping processes

In the case that required items listed above are generic, not design specific, and are covered by the QVP, citing the QVP is acceptable. Internal documentation must state the controlled document revision used for the PPP under consideration.

C-3.4 Quality Management System (QMS). The Contractor shall maintain, operate and continually improve a QMS acceptable to the Government in accordance with ISO 9001:2008 or equivalent. Quality and reliability will be continually monitored by the Government to include statistical process control (SPC) and other quality management metrics that depict the effectiveness of the QMS and the achievement of critical process control at both the Contractor's and major suppliers' locations. Major suppliers pertain to those who provide components, textile or hardware materials within the TDP. Examples of major suppliers include cloth, and hardware suppliers, and any other subcontractor used for an assembly or subassembly. The Government reserves the right to conduct audits of the Contractor's Quality

Management System (QMS) during all phases of the contract. The Contractor shall be responsible for correcting any deficiencies found during Government auditing or testing in all affected Contractor product. The Contractor shall maintain a calibration system in accordance with ANSI/ISO/ASQ Q10012-2003 or equivalent to ensure that all test/inspection, measurement, and diagnostic equipment to include all accessories and ancillary equipment are properly calibrated and identified by appropriate labeling.

C-3.5 Lot Definition. T11/MC6 lot sizes shall be equal to the Contractors offered delivery schedule quantities, by month.

C-3.6 Responsibility for Compliance. Items shall meet all requirements of this SOW. The absence of any inspection requirements shall not relieve the contractor of the responsibility of ensuring that all products of supplies submitted to the government for acceptance shall comply with all requirements of the SOW. Sampling inspection, as part of manufacturing operations, is an acceptable practice to ascertain conformance to requirements; however, this does not authorize submission of known defective material, either indicated or actual, nor does it commit the government to accept defective material. If there is a conflict between the stated requirements and the approved QVP, the more restrictive requirement shall apply.

C-3.7 Responsibility For Conformance Inspection. The Contractor shall be responsible for the performance of all inspection requirements specified herein in Section E-1, and in accordance with FAR 52.246-2. The Government reserves the right to perform, witness, or verify any of the inspections set forth herein where the inspections are deemed necessary to assure supplies and services conform to prescribed requirements. The Contractor shall be responsible for correcting any noncompliance found during Contractor and/or Government testing in all affected Contractor product.

C-3.8 Conformance Inspection Validation. DCMA QAR will provide in process conformation validation to those items inspected by the Contractor during production. DCMA QAR will also conduct conformance inspection listed per DCMA QASP and PM SCIE contract issued Quality Letter of Instruction, on samples selected for end item testing. Report will be in DCMA QAR format and will address lot number and list items inspected and will expound on those items with discrepancies. Report will be emailed to COR and PM SCIE quality representative.

C-3.9 Inventory. The Contractor, upon receipt of any failed testing shall quarantine all materials used in the production of the failed lot until Government disposition is rendered. The Contractor shall be responsible for maintaining, safeguarding, and preventing the use of quarantined materials into any on-going production.

C-3.10 Use of Contractor's Inspection and Test Equipment. The Contractor's inspection, measuring and testing devices shall be made available when required by the Government to determine conformance with contract requirements in accordance with FAR 52.246-2. The Contractor shall have a documented calibration program that outlines calibration procedures, schedules, and standards used. Standards shall be traceable to the National Institute of Standards and Testing (NIST) or other accredited body. If requested by the Government, the Contractor's personnel shall be made available to operate such devices and to verify their accuracy and condition.

C-3.11 Supplier Management. The Contractor is responsible for the work performed by their suppliers including any inspections and tests performed by the suppliers. The Contractor shall maintain documented evidence that its suppliers meet all criteria related to the contract's materials / processes. Documentation shall include any methods unique to this contract of supplier selection, retention, management, inspection and test validation or other supplier controls above and beyond that which is described in the Contractor's generic QMS. The Government reserves the right to, in coordination with the Prime Contractor, review/audit any suppliers of components. No review/audit of any suppliers by the Government will relieve the Contractor of its responsibility for its suppliers.

C-3.12 Inspection and Test Records. The Contractor shall maintain complete and accurate records of all inspections and tests, and shall make these records available for review by the Government upon request. These records shall be kept by the Contractor for 10 years after final payment has been made against the last delivery order placed to the Contractor under this contract.

C-3.13 Notification of Change. The Contractor shall notify the Government of any change in design, material, material suppliers, manufacturing processes (including quality control), or plant location. The Contractor shall also report any changes to the items included in the QVP and/or PPP.

C-3.13.1 Material and Material Supplier Changes. Contractors shall notify the Government of all changes in material and material suppliers. Also, Contractors shall ensure that produced end items conform to specified product and quality requirements and shall immediately report any deviation in form, fit, or function of items so produced.

C-3.13.2 Manufacturing Process Changes. A change in the process flow reviewed by the Government during the First Article Test as incorporated by Section E-1.2, such as combining operations or using additional/different equipment, constitutes a manufacturing process change. Any change in location or ownership of the plant where a previously qualified product was manufactured requires reevaluation of the qualification and approval of the Contracting Officer. Routine maintenance and the switching of comparable equipment are not considered a process change.

C-3.13.3 Notification and Request Procedures. To support the notification of material and material supplier changes evaluation, the Contractor shall supply the following to the Government: a sample of the textile or hardware from the new supplier in sufficient quantity to comply with MIL-DTL-6645 paragraph 3.2.3. Along with material sample, all applicable test reports and certificates of compliance, to include Berry Amendment compliance, shall be provided.

To support a manufacturing process flow change, the Contractor shall supply all supporting documentation for the process change.

Contractors may, and are encouraged to, use existing Request for Deviation procedures to seek Contracting Officer's approval.

C-3.13.4 Government Review and Approval Procedures. The Government reserves the right to review notifications under subsection C-3.13.3. Within five (5) business days of Contractor notification, the Government will either approve the change or notify the Contractor whether an additional evaluation by the Government will be required to approve or disapprove the change. If further evaluation is required, the Government will provide an approval or disapproval of the change to the Contractor no later than 30 calendar days after the initial notification by the Contractor.

C-3.14 Production Management. The Contractor shall make available for review by the Government the production management plan, status of critical suppliers, description of resource shortfalls, schedules, and description of technical risks and issues.

C-3.15 Berry Amendment Compliance. The Prime Contractor and the entire supply chain are required to adhere to the Berry Amendment. The Prime Contractor shall educate and mentor the entire supply chain in the implementation and maintenance of Berry Amendment compliance. The Prime Contractor shall assess the entire supply chain for compliance to the Berry Amendment, and shall maintain documentation of Berry product compliance, and supply chain education, mentoring, and assessments. The Government will assess the Prime Contractors compliance to the Berry Process in conjunction with the Quality Systems assessment of Purchasing and Supplier Control, to include but not limited to Berry Certification and documentation.

The Government cannot accept noncompliant product, and the contractor shall not be paid for any items that are in violation of the Berry Amendment. If a Berry Amendment violation is determined to have occurred after the government has accepted delivery, the contractor is required to replace the item in violation of the Act with an item from a domestic source, at their own expense. The Government may pursue additional claims against the contractor if the Government incurred other damages due to non-compliance.

C-3.16 Failed Item Analysis/Corrective Action Reports (CAR). For each failure that results in a CAR, the contractor shall conduct a root cause failure analysis and provide such reports as required to facilitate the completion of the CAR as directed by the Defense Contract Management Agency (DCMA) Quality Assurance Representative (QAR) and the Contracting Officer's Representative (COR). A failure constitutes non-conformance to the TDP. The initial CAR shall be submitted to the DCMA QAR and the COR for review NLT 15 days after occurrence. E-mail is the preferred method of notification and CAR submittal.

The CAR, at a minimum, shall include the date of failure, item, lot number and size, detailed failure description, failure analysis to identify the root cause for the failure, failure history, proposed root cause corrective action and validation plan to assess the effectiveness of the corrective action, and proposed disposition of the failed item and lot, and containment actions. Containment shall address all suspect products, including end items in plant and already delivered to the Government as well as material work in process, at receiving, or in transit. The CAR shall identify why the defect was not detected, impact to similar product or processes, and the process controls in place or planned to prevent the problem from recurring. The Government may not accept product at any time while the CAR is pending based on the impact of the failure in question. The CAR shall not be considered closed until the Government has concurred on the report. Concurrence by the Government is required prior to shipment of any potentially affected production units. Failures occurring during Government conducted testing are subject to this requirement.

C-3.17 Lot Traceability. The Contractor shall maintain complete and accurate records of the system serial numbers that correspond to each lot produced, and shall make these records available for review by the Government upon request. These records shall be kept by the Contractor for 10 years after final payment has been made against the last delivery order placed to the Contractor under this contract.

C-3.18 Test Reporting. All test reports requested by the government shall be sent to the COR and will include as a minimum, the contract number, reason for test, results of the testing, lot number or serial number of the test item, date of the test and the detail specifications of the tested item.

C-3.19 Conformance Inspection Reporting. The Contractor shall subject all T11/MC6 systems to in-process inspection as outlined in the QVP, PPP, and a list of key critical processes/inspections with the appropriate failure free verification criteria to identify and remove defects that are attributed to defects involving materials, workmanship, and other non-conforming anomalies. The Contractor shall track and investigate causes of defects and close quality issues in accordance with the Contractors internal procedures for the purpose of continuously improving the screening and the manufacturing processes. The Contractor shall make all performance measurements available to the Government for onsite review at any time. The Contractor shall brief overall results at program reviews after initiation of production.

C-3.20 Configuration Control. Any proposed changes to the Functional Baseline or approved Product Baseline shall be made via Engineering Change Proposal (ECP). All ECPs, shall be submitted in Contractors format. Requests for Deviation (RFD) and Requests for Waiver (RFW) against a production base lined system shall be submitted to the government for review and approval. Submit using form DD1694. The Contractor shall submit all ECPs, RFDs, and RFWs to the Government for review and disposition prior to implementation. The Government requires electronic submittal of ECPs, RFDs, and RFWs. The Contractor shall provide documentation, equipment, facilities and personnel as deemed necessary by the Government to support and verify all Contractor-requested variances or configuration changes.

C-3.21 Product Drawings. The Contractor shall submit all drawing changes, new drawings, or associated lists proposed by ECP in

(iv) Other electronic formats. Before preparing your ECPs, VECPs or RFDs in any other electronic format, please e-mail the engineer, copy-furnished to the buyer and ACO, to obtain a decision as to the format's acceptability. Failure to e-mail the engineer to seek an alternate format's acceptability may result in rejection of your submission. All alternate methods must be at no cost to the Government. The Government reserves the right to perform any of the tests and inspections set forth deemed necessary to ensure the supplies conform to prescribed requirements.

- a) First Article Test (FAT) (see E-1.2)
- b) Lot Acceptance Test (LAT) (see E-1.3)
- c) Conformance Inspection (CI) (see E-1.3)

E-1.1.1 The Contractor shall conduct test and inspection per the QVP, to demonstrate continued conformance to all specification requirements. The Contractor shall provide the entire completed production lot for DCMA sample selection to be used during LAT and CI. In the event of a failure during a FAT or LAT, the Government will withhold any and/or all potentially affected production items from acceptance, and the Contractor shall prepare and submit a Failure Analysis and Corrective Action Report (FACAR) in accordance with paragraph C-3.16. If the Contractor makes any changes to the materials or processes utilized to manufacture the FAT, the Government may require a requalification at the Contractors expense. The Government reserves the right to perform, witness, and/or verify any of the inspections set forth herein where such inspections deemed necessary to ensure that supplies and services conform to prescribed requirements. The Government will conduct both testing and conformance inspection on the T11/MC6 as part of the initial FAT and follow-on LAT to ensure that the contract requirements are satisfied both technically as well as in an operational environment. The Government will not approve the FAT or LAT until successful completion of testing and conformance inspection.

E-1.2 First Article Test. A First Article Test (FAT) will be performed by the Government. An approved FAT shall stay in effect until LAT failure rules apply (see E-1.4). Accordingly, the Contractor shall prepare and submit a First Article Test Report (FATR) consisting of all inspections and tests results in the format as specified (see CDRL A003).

E-1.2.1 The Government will inspect five (5) complete T11 and five (5) complete MC6 parachute assemblies in accordance with all aspects of the T11/MC6 TDP. The Government will select one (1) complete parachute assembly of each to perform the ripcord pull test and will pack the main and reserve parachute assembly (See E-1.2.5, Production Tests during FAT).

E-1.2.2 The Government will conduct an audit of the Contractors Quality Management System (QMS) for all products/processes related to the contract during FAT and/or reserves the right to conduct additional audits at any other stage during contract performance. The Contractor shall provide an overview of their QMS and state whether their QMS is registered, the registrar, and the dates of registration. Any exceptions to ISO 9001:2008 shall be clearly stated. The Contractor shall make their QMS documentation available to the Government. The Contractor shall be responsible for correcting any deficiencies found during Government auditing or testing in all affected Contractor product.

E-1.2.3 The Contractor shall document in report format and present to the Government the following items for all FAT parachute assemblies: Any deviations to the TDP or other requirements specified herein shall be submitted in writing to the Contracting Officer and approved prior to the FAT.

E-1.2.3.1 The Contractor shall provide evidence of all material conformity to requirements as specified by the T11/MC6 TDP used in the manufacture of the FAT, including but not limited to test reports, inspection reports, etc. In addition, Air Permeability testing shall be completed by the Contractor and results submitted to the Government on all applicable raw materials prior to construction of the T11/MC6 for FAT. Textile materials more than 3.5 years old shall not be used per MIL-DTL-6645 para 3.3.2. Any deviations from the TDP or other requirements specified herein shall be submitted and approved prior to the FAT.

E-1.2.3.2 Air permeability testing, per paragraph 6.2.g of MIL-DTL-6645 for main canopy, reserve canopy, and reserve pilot chute, shall be conducted. Air permeability testing for the reserve pilot chute requires only two random samplings at opposite locations on the respective chutes IAW MIL-DTL-6645 Para 4.7.1. Results of the Air Permeability Testing shall include the make/model and calibration date of the air permeability machine used in testing.

E-1.2.3.3 The Contractor shall provide any proof load or other test results specified on the TDP.

E-1.2.4 The FAT will be inspected to the applicable tables of MIL-STD-849 and the air permeability tests (see MIL-STD-849 paragraph

E-1.2.4.1 Any sample unit exceeding the defects of Table 1 of MIL-STD-849 for the parachute system components/repair parts shall be cause for rejection of the FAT.

E-1.2.5 Production Tests during FAT

E-1.2.5.1 Ripcord pull test. The Contractor shall perform a ripcord pull test in accordance with MIL-DTL-6645 paragraph 4.7.2.1, following established procedures in Technical Manual 10-1670-327-23&P. Certificates of Conformance (see C-3.23) shall be presented to the DCMA QAR at the time of end item conformance inspection. E-1.3.2 The Government reserves the right to request inspection reports and material certifications from the Contractor for the lot based upon sampling per ANSI/ASQ Z1.4.

E-1.4 LAT Failure Protocol.

E-1.4.1 Single Failure events and outcomes. Upon failure occurrence of any single Lot Acceptance Test (LAT) or conformance inspection lot test, the Contractor shall segregate the material of the lot in question from all other production lots ongoing, conduct a root cause failure analysis, and provide Failure Analysis & Corrective Actions Report (see content description above) to the Contacting Officers Representative (COR) NLT ten (10) working days after notification of failure. The COR will determine within ten (10) working days of receipt of FACAR if production of the approved FAT configuration may resume or if the Contractor must conduct a new FAT for the issuance of a new FAT Approval Letter. If a new FAT is required, the Contractor shall submit the number of samples required for the conduct of a new FAT (at the Contractors expense) as directed by the COR, for the issuance of a new FAT Approval Letter. The FAT Report remains the property of the Government.

E-1.4.2 The Contractor fails Lot Acceptance Testing (LAT) requirements on two (2) consecutive lots. Consecutive lots are defined by production dates and not testing dates. Should this occur, the Government will withhold DD250 acceptance and may immediately cease all production (Stop Work) from the Contractor. The Contractor shall segregate the material of the lot in question from all other production lots ongoing, conduct an analysis, and submit a FACAR (see content description above) to the COR NLT ten (10) working days after notification of failure. Government acceptance will not resume until the FACAR has been approved or conditionally approved via letter from the contracting officer. The COR will determine within ten (10) working days of receipt of FACAR if production of the approved FAT configuration may resume or if the Contractor shall conduct a new FAT for the issuance of a new FAT Approval Letter. If a new FAT is required, the Contractor shall submit 5 units for the conduct of a new FAT (at the Contractors expense) as directed by the COR, for the issuance of a new FAT Approval Letter. The FAT Report remains the property of the Government.

E-1.4.3 A pattern of failure demonstrated outside of the two (2) failed consecutive lots rule stated above. Should this occur, the Government will withhold DD250 acceptance and may immediately cease all production (Stop Work) from the Contractor. The Contractor shall segregate the material of the lot in question from all other production lots ongoing, conduct an analysis, and submit a FACAR (see content description above) to the COR NLT ten (10) working days after notification of failure. The COR will determine within ten (10) working days of receipt of FACAR if production of the approved FAT configuration may resume or if the Contractor shall conduct a new FAT for the issuance of a new FAT Approval Letter. If a new FAT is required, the Contractor shall submit the number of samples required for the conduct of a new FAT (at the Contractors expense) as directed by the COR, for the issuance of a new FAT Approval Letter. The FAT Report remains the property of the Government.

"Advance shipment notice" means an electronic notification used to list the contents of a shipment of goods as well as additional information relating to the shipment, such as passive radio frequency identification (RFID) or item unique identification (IUID) information, order information, product description, physical characteristics, type of packaging, marking, carrier information, and configuration of goods within the transportation equipment.

"Bulk commodities" means the following commodities, when shipped in rail tank cars, tanker trucks, trailers, other bulk wheeled conveyances, or pipelines:

- (1) Sand.
- (2) Gravel.
- (3) Bulk liquids (water, chemicals, or petroleum products).
- (4) Ready-mix concrete or similar construction materials.
- (5) Coal or combustibles such as firewood.
- (6) Agricultural products such as seeds, grains, or animal feed.

"Case" means either a MIL-STD-129 defined exterior container within a palletized unit load or a MIL-STD-129 defined individual shipping container.

"Electronic Product Code\TM\ (EPC)" means an identification scheme for universally identifying physical objects via RFID tags and other means. The standardized EPC\TM\ data consists of an EPC\TM\ (or EPC\TM\ identifier) that uniquely identifies an individual object, as well as an optional filter value when judged to be necessary to enable effective and efficient reading of the EPC\TM\ tags. In addition to this standardized data, certain classes of EPC\TM\ tags will allow user-defined data. The EPC\TM\ Tag Data Standards will define the length and position of this data, without defining its content.

"EPCglobal" means a subscriber-driven organization comprised of industry leaders and organizations focused on creating global standards for the adoption of passive RFID technology.

"Exterior container" means a MIL-STD-129 defined container, bundle, or assembly that is sufficient by reason of material, design, and construction to protect unit packs and intermediate containers and their contents during shipment and storage. It can be a unit pack or a container with a combination of unit packs or intermediate containers. An exterior container may or may not be used as a shipping container.

"Palletized unit load" means a MIL-STD-129 defined quantity of items, packed or unpacked, arranged on a pallet in a specified manner and secured, strapped, or fastened on the pallet so that the whole palletized load is handled as a single unit. A palletized or skidded load is not considered to be a shipping container. A loaded 463L System pallet is not considered to be a palletized unit load. Refer to the Defense Transportation Regulation, DoD 4500.9-R, Part II, Chapter 203, for marking of 463L System pallets.

"Passive RFID tag" means a tag that reflects energy from the reader/interrogator or that receives and temporarily stores a small amount of energy from the reader/interrogator signal in order to generate the tag response. The only acceptable tags are EPC Class 1 passive RFID tags that meet the EPCglobal\TM\ Class 1 Generation 2 standard.

"Radio frequency identification (RFID)" means an automatic identification and data capture technology comprising one or more reader/interrogators and one or more radio frequency transponders in which data transfer is achieved by means of suitably modulated inductive or radiating electromagnetic carriers.

"Shipping container" means a MIL-STD-129 defined exterior container that meets carrier regulations and is of sufficient strength, by reason of material, design, and construction, to be shipped safely without further packing (e.g., wooden boxes or crates, fiber and metal drums, and corrugated and solid fiberboard boxes).

"Subcontractor" means any supplier, distributor, vendor, or firm that furnished supplies or services to or for a prime contractor or another subcontractor.

"United States," means the 50 States, the District of Columbia, and outlying areas.

(b) Code of business ethics and conduct.

(1) Within 30 days after contract award, unless the Contracting Officer establishes a longer time period, the Contractor shall--

(3)(i) The Contractor shall timely disclose, in writing, to the agency Office of the Inspector General (OIG), with a copy to the Contracting Officer, whenever, in connection with the award, performance, or closeout of this contract or any subcontract thereunder, the Contractor has credible evidence that a principal, employee, agent, or subcontractor of the Contractor has committed--

(A) A violation of Federal criminal law involving fraud, conflict of interest, bribery, or gratuity violations found in Title 18 of the United States Code; or

(B) A violation of the civil False Claims Act (31 U.S.C. 3729-3733).

(ii) The Government, to the extent permitted by law and regulation, will safeguard and treat information obtained pursuant to the Contractors disclosure as confidential where the information has been marked confidential or proprietary by the company. To the extent permitted by law and regulation, such information will not be released by the Government to the public pursuant to a Freedom of Information Act request, 5 U.S.C. Section 552, without prior notification to the Contractor. The Government may transfer documents provided by the Contractor to any department or agency within the Executive Branch if the information relates to matters within the organizations jurisdiction.

(iii) If the violation relates to an order against a Governmentwide acquisition contract, a multi-agency contract, a multiple-award schedule contract such as the Federal Supply Schedule, or any other procurement instrument intended for use by multiple agencies, the Contractor shall notify the OIG of the ordering agency and the IG of the agency responsible for the basic contract.

(c) Business ethics awareness and compliance program and internal control system. This paragraph (c) does not apply if the Contractor has represented itself as a small business concern pursuant to the award of this contract or if this contract is for the acquisition of a commercial item as defined at FAR 2.101. The Contractor shall establish the following within 90 days after contract award, unless the Contracting Officer establishes a longer time period:

(1) An ongoing business ethics awareness and compliance program.

(i) This program shall include reasonable steps to communicate periodically and in a practical manner the Contractors standards and procedures and other aspects of the Contractors business ethics awareness and compliance program and internal control system, by conducting effective training programs and otherwise disseminating information appropriate to an individuals respective roles and responsibilities.

(ii) The training conducted under this program shall be provided to the Contractors principals and employees, and as appropriate, the Contractors agents and subcontractors.

(2) An internal control system.

(i) The Contractors internal control system shall--

(A) Establish standards and procedures to facilitate timely discovery of improper conduct in connection with Government contracts; and

(B) Ensure corrective measures are promptly instituted and carried out.

(ii) At a minimum, the Contractors internal control system shall provide for the following:

(A) Assignment of responsibility at a sufficiently high level and adequate resources to ensure effectiveness of the business ethics awareness and compliance program and internal control system.

(B) Reasonable efforts not to include an individual as a principal, whom due diligence would have exposed as having engaged in conduct that is in conflict with the Contractors code of business ethics and conduct.

(C) Periodic reviews of company business practices, procedures, policies, and internal controls for compliance with the Contractors code of business ethics and conduct and the special requirements of Government contracting, including--

(1) Monitoring and auditing to detect criminal conduct;

(2) Periodic evaluation of the effectiveness of the business ethics awareness and compliance program and internal control system, especially if criminal conduct has been detected; and

(3) Periodic assessment of the risk of criminal conduct, with appropriate steps to design, implement, or modify the business ethics awareness and compliance program and the internal control system as necessary to reduce the risk of criminal conduct identified through this process.

(D) An internal reporting mechanism, such as a hotline, which allows for anonymity or confidentiality, by which employees may report suspected instances of improper conduct, and instructions that encourage employees to make such reports.

(E) Disciplinary action for improper conduct or for failing to take reasonable steps to prevent or detect improper conduct.

(F) Timely disclosure, in writing, to the agency OIG, with a copy to the Contracting Officer, whenever, in connection with the award, performance, or closeout of any Government contract performed by the Contractor or a subcontract thereunder, the Contractor has credible evidence that a principal, employee, agent, or subcontractor of the Contractor has committed a violation of Federal criminal law involving fraud, conflict of interest, bribery, or gratuity violations found in Title 18 U.S.C. or a violation of the civil False Claims Act (31 U.S.C. 3729-3733).

(1) If a violation relates to more than one Government contract, the Contractor may make the disclosure to the agency OIG and Contracting Officer responsible for the largest dollar value contract impacted by the violation.

"Individual contract plan" means a subcontracting plan that covers the entire contract period (including option periods), applies to a specific contract, and has goals that are based on the offerors planned subcontracting in support of the specific contract, except that

indirect costs incurred for common or joint purposes may be allocated on a prorated basis to the contract.

"Master plan" means a subcontracting plan that contains all the required elements of an individual contract plan, except goals, and may be incorporated into individual contract plans, provided the master plan has been approved.

"Subcontract" means any agreement (other than one involving an employer-employee relationship) entered into by a Federal Government prime Contractor or subcontractor calling for supplies or services required for performance of the contract or subcontract.

(c) The offeror, upon request by the Contracting Officer, shall submit and negotiate a subcontracting plan, where applicable, that separately addresses subcontracting with small business, veteran-owned small business, service-disabled veteran-owned small business, HUBZone small business concerns, small disadvantaged business, and women-owned small business concerns. If the offeror is submitting an individual contract plan, the plan must separately address subcontracting with small business, veteran-owned small business, service-disabled veteran-owned small business, HUBZone small business, small disadvantaged business, and women-owned small business concerns, with a separate part for the basic contract and separate parts for each option (if any). The plan shall be included in and made a part of the resultant contract. The subcontracting plan shall be negotiated within the time specified by the Contracting Officer. Failure to submit and negotiate the subcontracting plan shall make the offeror ineligible for award of a contract.

(d) The offerors subcontracting plan shall include the following:

(1) Goals, expressed in terms of percentages of total planned subcontracting dollars, for the use of small business, veteran-owned small business, service-disabled veteran-owned small business, HUBZone small business, small disadvantaged business, and women-owned small business concerns as subcontractors. The offeror shall include all sub-contracts that contribute to contract performance, and may include a proportionate share of products and services that are normally allocated as indirect costs. In accordance with 43 U.S.C. 1626:

(i) Subcontracts awarded to an ANC or Indian tribe shall be counted towards the subcontracting goals for small business and small disadvantaged business (SDB) concerns, regardless of the size or Small Business Administration certification status of the ANC or Indian tribe.

(ii) Where one or more subcontractors are in the subcontract tier between the prime contractor and the ANC or Indian tribe, the ANC or Indian tribe shall designate the appropriate contractor(s) to count the subcontract towards its small business and small disadvantaged business subcontracting goals.

(A) In most cases, the appropriate Contractor is the Contractor that awarded the subcontract to the ANC or Indian tribe.

(D) If the Contracting Officer does not receive a copy of the ANCs or the Indian tribes written designation within 30 days of the subcontract award, the Contractor that awarded the subcontract to the ANC or Indian tribe will be considered the designated Contractor.

(2) A statement of--

(i) Total dollars planned to be subcontracted for an individual contract plan; or the offerors total projected sales, expressed in dollars, and the total value of projected subcontracts to support the sales for a commercial plan;

(ii) Total dollars planned to be subcontracted to small business concerns (including ANC and Indian tribes);

(iii) Total dollars planned to be subcontracted to veteran-owned small business concerns;

(iv) Total dollars planned to be subcontracted to service-disabled veteran-owned small business;

(v) Total dollars planned to be subcontracted to HUBZone small business concerns;

(vi) Total dollars planned to be subcontracted to small disadvantaged business concerns (including ANCs and Indian tribes); and

(vii) Total dollars planned to be subcontracted to women-owned small business concerns.

(3) A description of the principal types of supplies and services to be subcontracted, and an identification of the types planned for subcontracting to--

(i) Small business concerns;

(ii) Veteran-owned small business concerns;

(iii) Service-disabled veteran-owned small business concerns;

(iv) HUBZone small business concerns;

(v) Small disadvantaged business concerns; and

(vi) Women-owned small business concerns.

(4) A description of the method used to develop the subcontracting goals in paragraph (d)(1) of this clause.

(5) A description of the method used to identify potential sources for solicitation purposes (e.g., existing company source lists, the System for Award Management (SAM), veterans service organizations, the National Minority Purchasing Council Vendor Information Service, the Research and Information Division of the Minority Business Development Agency in the Department of Commerce, or small, HUBZone, small disadvantaged, and women-owned small business trade associations). A firm may rely on the information contained in SAM as an accurate representation of a concern's size and ownership characteristics for the purposes of maintaining a small, veteran-owned small, service-disabled veteran-owned small, HUBZone small, small disadvantaged, and women-owned small business source list. Use of SAM as its source list does not relieve a firm of its responsibilities (e.g., outreach, assistance, counseling, or publicizing subcontracting opportunities) in this clause.

(6) A statement as to whether or not the offeror included indirect costs in establishing subcontracting goals, and a description of the method used to determine the proportionate share of indirect costs to be incurred with--

(i) Small business concerns (including ANC and Indian tribes);

(ii) Veteran-owned small business concerns;

(iii) Service-disabled veteran-owned small business concerns;

(iv) HUBZone small business concerns;

(v) Small disadvantaged business concerns (including ANC and Indian tribes); and

(vi) Women-owned small business concerns.

(7) The name of the individual employed by the offeror who will administer the offerors subcontracting program, and a description of the duties of the individual.

(8) A description of the efforts the offeror will make to assure that small business, veteran-owned small business, service-disabled veteran-owned small business, HUBZone small business, small disadvantaged business, and women-owned small business concerns have an equitable opportunity to compete for subcontracts.

(9) Assurances that the offeror will include the clause of this contract entitled "Utilization of Small Business Concerns" in all subcontracts that offer further subcontracting opportunities, and that the offeror will require all subcontractors (except small business concerns) that receive subcontracts in excess of \$650,000 (\$1.5 million for construction of any public facility) with further subcontracting possibilities to adopt a subcontracting plan that complies with the requirements of this clause.

(10) Assurances that the offeror will--

(i) Cooperate in any studies or surveys as may be required;

(ii) Submit periodic reports so that the Government can determine the extent of compliance by the offeror with the subcontracting plan;

(iii) Submit Standard Form (SF) 294 Subcontracting Report for Individual Contract in accordance with paragraph (1) of this clause. Submit the Summary Subcontract Report (SSR), in accordance with paragraph (1) of this clause using the Electronic Subcontracting Reporting System (eSRS) at <http://www.esrs.gov>. The reports shall provide information on subcontract awards to small business concerns (including ANCs and Indian tribes that are not small businesses), veteran-owned small business concerns, service-disabled veteran-owned small business concerns, HUBZone small business concerns, small disadvantaged business concerns (including ANCs and Indian tribes that have not been certified by the Small Business Administration as small disadvantaged businesses), women-owned small business concerns, and Historically Black Colleges and Universities and Minority Institutions. Reporting shall be in accordance with this clause, or as provided in agency regulations; and

(iv) Ensure that its subcontractors with subcontracting plans agree to submit the SF 294 in accordance with paragraph (1) of this clause. Ensure that its subcontractors with subcontracting plans agree to submit the SSR in accordance with paragraph (1) of this clause using the eSRS.

(11) A description of the types of records that will be maintained concerning procedures that have been adopted to comply with the requirements and goals in the plan, including establishing source lists; and a description of the offerors efforts to locate small business, veteran-owned small business, service-disabled veteran-owned small business, HUBZone small business, small disadvantaged business, and women-owned small business concerns and award subcontracts to them. The records shall include at least the following (on a plant-wide or company-wide basis, unless otherwise indicated):

(i) Source lists (e.g., SAM), guides, and other data that identify small business, veteran-owned small business, service-disabled veteran-owned small business, HUBZone small business, small disadvantaged business, and women-owned small business concerns.

(ii) Organizations contacted in an attempt to locate sources that are small business, veteran-owned small business, service-disabled veteran-owned small business, HUBZone small business, small disadvantaged business, or women-owned small business concerns.

(iii) Records on each subcontract solicitation resulting in an award of more than \$150,000, indicating--

(v) Records of internal guidance and encouragement provided to buyers through

(A) Workshops, seminars, training, etc.; and

(B) Monitoring performance to evaluate compliance with the programs requirements.

(vi) On a contract-by-contract basis, records to support award data submitted by the offeror to the Government, including the name, address, and business size of each subcontractor. Contractors having commercial plans need not comply with this requirement.

(e) In order to effectively implement this plan to the extent consistent with efficient contract performance, the Contractor shall perform the following functions:

(1) Assist small business, veteran-owned small business, service-disabled veteran-owned small business, HUBZone small business, small disadvantaged business, and women-owned small business concerns by arranging solicitations, time for the preparation of bids, quantities, specifications, and delivery schedules so as to facilitate the participation by such concerns. (2) Provide adequate and timely consideration of the potentialities of small business, veteran-owned small business, service-disabled veteran-owned small business, HUBZone small business, small disadvantaged business, and women-owned small business concerns in all "make-or-buy" decisions.

(3) Counsel and discuss subcontracting opportunities with representatives of small business, veteran-owned small business, service-disabled veteran-owned small business, HUBZone small business, small disadvantaged business, and women-owned small business firms.

(4) Confirm that a subcontractor representing itself as a HUBZone small business concern is identified as a certified HUBZone small business concern by accessing the SAM database or by contacting SBA.

(5) Provide notice to subcontractors concerning penalties and remedies for misrepresentations of business status as small, veteran-owned small business, HUBZone small, small disadvantaged, or women-owned small business for the purpose of obtaining a subcontract that is to be included as part or all of a goal contained in the Contractors subcontracting plan.

(6) For all competitive subcontracts over the simplified acquisition threshold in which a small business concern received a small business preference, upon determination of the successful subcontract offeror, the Contractor must inform each unsuccessful small business subcontract offeror in writing of the name and location of the apparent successful offeror prior to award of the contract.

(f) A master plan on a plant or division-wide basis that contains all the elements required by paragraph (d) of this clause, except goals, may be incorporated by reference as a part of the subcontracting plan required of the offeror by this clause; provided--

(1) The master plan has been approved;

(2) The offeror ensures that the master plan is updated as necessary and provides copies of the approved master plan, including evidence of its approval, to the Contracting Officer; and

(3) Goals and any deviations from the master plan deemed necessary by the Contracting Officer to satisfy the requirements of this contract are set forth in the individual subcontracting plan.

(g) A commercial plan is the preferred type of subcontracting plan for contractors furnishing commercial items. The commercial plan shall relate to the offerors planned subcontracting generally, for both commercial and Government business, rather than solely to the Government contract. Once the Contractors commercial plan has been approved, the Government will not require another subcontracting plan from the same Contractor while the plan remains in effect, as long as the product or service being provided by the Contractor continues to meet the definition of a commercial item. A Contractor with a commercial plan shall comply with the reporting requirements stated in paragraph (d)(10) of this clause by submitting one SSR in eSRS for all contracts covered by its commercial plan. This report shall be acknowledged or rejected in eSRS by the Contracting Officer who approved the plan. This report shall be submitted within 30 days after the end of the Governments fiscal year.

(h) Prior compliance of the offeror with other such subcontracting plans under previous contracts will be considered by the Contracting Officer in determining the responsibility of the offeror for award of the contract.

(i) A contract may have no more than one plan. When a modification meets the criteria in 19.702 for a plan, or an option is exercised, the goals associated with the modification or option shall be added to those in the existing subcontract plan.

(j) Subcontracting plans are not required from subcontractors when the prime contract contains the clause at 52.212-5, Contract Terms and Conditions Required to Implement Statutes or Executive Orders Commercial Items, or when the subcontractor provides a commercial item subject to the clause at 52.244-6, Subcontracts for Commercial Items, under a prime contract.

(k) The failure of the Contractor or subcontractor to comply in good faith with--

(1) The clause of this contract entitled "Utilization Of Small Business Concerns;" or

(2) An approved plan required by this clause, shall be a material breach of the contract.

(1) The Contractor shall submit a SF 294. The Contractor shall submit SSRs using the web-based eSRS at <http://www.esrs.gov>. Purchases from a corporation, company, or subdivision that is an affiliate of the prime Contractor or subcontractor are not included in these reports. Subcontract award data reported by prime Contractors and subcontractors shall be limited to awards made to their immediate next-tier subcontractors. Credit cannot be taken for awards made to lower tier subcontractors, unless the Contractor or subcontractor has been designated to receive a small business or small disadvantaged business credit from an ANC or Indian tribe. Only subcontracts involving performance in the U.S. or its outlying areas should be included in these reports with the exception of subcontracts under a contract awarded by the State Department or any other agency that has statutory or regulatory authority to require subcontracting plans for subcontracts performed outside the United States and its outlying areas.

(1) SF 294. This report is not required for commercial plans. The report is required for each contract containing an individual subcontract plan. For prime contractors the report shall be submitted to the contracting officer, or as specified elsewhere in this contract. In the case of a subcontract with a subcontracting plan, the report shall be submitted to the entity that awarded the subcontract.

(i) The report shall be submitted semi-annually during contract performance for the periods ending March 31 and September 30. A

(1) To use, duplicate and disclose any data to which this clause is applicable. The purposes of this right are to --

(ii) Obtain medical treatment for those affected by the material; and

(iii) Have others use, duplicate, and disclose the data for the Government for these purposes.

In no case shall the Government recover costs greater than the increased cost to the Government, in the aggregate, on the relevant contracts subject to the price adjustment, unless the Contractor made a change in its cost accounting practices of which it was aware or should have been aware at the time of price negotiations and which it failed to disclose to the Government.

(b) If the parties fail to agree whether the Contractor or a subcontractor has complied with an applicable CAS in 48 CFR 9904 or a CAS rule or regulation in 48 CFR 9903 and as to any cost adjustment demanded by the United States, such failure to agree will constitute a dispute under the Contract Disputes Act (41 U.S.C. 601).
