(2) Within 10 working days after the protest is filed, the contracting officer, with the assistance of legal counsel, shall file with the HQAMC Office of Command Counsel, ATTN: AMCCC-PL, an administrative report responsive to the protest. (3) The HQAMC protest decision authority will issue a written decision within 20 working days after the filing of the protest.
