## DESCRIPTION/SPECIFICATIONS/WORK STATEMENT

## C.1 SCOPE

C.1.1 PURPOSE: The Contractor shall provide the Government with a Debris Blower capable of mounting to and operating from the Buffalo Mine Protected Clearance Vehicle (MPCV). The blower capability shall move debris from the route, and from the sides of the routes exposing explosive hazards while on the move ahead of the host platform at route clearance speeds. These capabilities shall enhance operators capabilities and shall assist in disrupting or defeating threats.

## C.3 Requirements

C.3.1 Contractor Objective: The Contractor shall provide the Debris Blower described herein so that the USG may integrate the Debris Blower onto the MPCV to expose and clear potential explosive hazards during Route Clearance operations by Combat Engineers. The Debris Blower consists of the following components: one blower assembly, with all supporting hardware, a control system, remote control operable from within the vehicle, and finally a Vehicle Integration Kit (VIK).

## C.3.2 Debris Blower System Requirements

## C.3.2.1 Operator Control Unit

C.3.2.1.1 Controller. The Debris Blower shall be operable by one soldier via wired remote (not larger than 150 cubic inches, 2 pounds, prefer smaller) from any seat inside the host vehicle. The controller shall have an I/O port for 1000BASE-T (Gigabit) Ethernet to allow for remote operation via other military systems.

C.3.2.1.1.1 Hydraulic. Switches for air velocity, nozzle direction, headlights, and infrared lights shall be included in controller.

C.3.2.1.1.2 Engine. Switches for engine start/ and shutdown, air velocity, nozzle direction, headlights, and infrared lights shall be included in controller.

## C.3.2.1.2 Runtime

C.3.2.1.2.1 Hydraulic. The Debris Blower shall be able to function continuous at the maximum rated output for the hydraulic pump for 8 hours under operating conditions of -25\b0F to +135\b0F

C.3.2.1.2.2 Engine. The Debris Blower shall be able to function continuous at the maximum rated engine output for 8 hours under operating conditions of -25\b0F to +135\b0F without the need to refuel.

## C.3.2.1.3 Fuels/Lubricants

C.3.2.1.3.1 Hydraulic. The Debris Blower shall operate with Dexron 6 hydraulic oil.

C.3.2.1.3.2 Engine. The Debris Blower shall operate with JP8 fuel. Engine oil shall be in accordance with engine manufacture specifications.

C.3.2.1.4 Nozzle. The Debris Blower nozzle shall be modular and reconfigurable in the field to allow for variations in configuration, including a 30 degree, 60 degree, and 90 degree nozzle attachments. The nozzle shall be capable of 270 degree rotation about the longitudinal axis of the vehicle without dismount, and additional 90 degree manual adjustment from forward (relative to vehicle orientation) to oblique.

C.3.2.1.5 Maintenance. 90% of all field level corrective maintenance to repair loss of an essential function of the Debris Blower shall be completed within 60 minutes. The Debris Blower shall be repairable by field level maintenance Soldiers using standard mechanics hand tools, Buffalo BII, and Special Tools listed in C.2.

C.3.2.1.6 System Weight

C.3.2.1.6.1 Hydraulic. The Debris Blower weight shall not exceed 290 lbs. This weight includes all fluids and components housed on the system frame. This weight does not include the vehicle integration kit, the hydraulic pump, or any other components related to the A-Kit.

C.3.2.1.6.2 Engine. The Debris Blower weight shall not exceed 570 lbs. This weight includes all fluids and components housed on the system frame. This weight includes a full fuel tank. This weight does not include the vehicle integration kit, or any other components related to the A-Kit.

C.3.2.1.7 Safety. The Debris Blower shall have applicable warning labels and protective guards placed on all hazardous components in accordance with MIL-STDS specified in C.2.

C.3.2.1.8 Paint. The Debris Blower components shall be painted with Chemical Agent Resistance Coating (CARC) tan paint in accordance with MIL-STDS specified in C.2.

C.3.2.1.9 Lift/Tie Down. The Debris Blower shall have Lift/Tie Down provisions capable of transporting by air, rail, and ground in accordance with MIL-STD-209K.

C.3.2.1.10 White Lights. The Debris Blower shall have an organic light kit capable of being tied in to the MPCV light system wiring harness. NSN 6220016161079 shall be sourced to fulfill this requirement. It is the same component currently on the MPCV. C.3.2.1.11 Infrared Lights. The Debris Blower shall have an organic infrared light kit capable of being tied in to the MPCV light system wiring harness. NSN- 6210015570642 shall be sourced to fulfill this requirement. It is the same component currently on the MPCV.

C.3.2.1.12 Frame. The Debris Blower frame shall be made of Aluminum. The frame shall support the blower system in a cantilevered position on the front bumper of the Buffalo via the Vehicle Integration Kit interface. The frame shall be designed in such a way that the frame supports installation of the debris blower to the MPCV in less than 30 minutes.

C.3.2.1.13 Orientation

C.3.2.1.13.1 Hydraulic. The Debris Blower shall be mounted on the front bumper of the Buffalo. The orientation of components in Buffalo Turbine Part # BT-HYSS2 is the objective configuration.

C.3.2.1.13.2 Engine. The Debris Blower shall be mounted on the front bumper of a RG-31. The system shall be designed so that when installed on the vehicle, the turbine will be in the center, the fuel tank will be curb side and the engine will be on the drivers side of the vehicle. All components are to be in line and parallel with the vehicle front bumper.

C.3.2.1.14 Corrosion Prevention. Metallic components shall be manufactured and properly shielded in order to prevent corrosion in accordance with MIL-HDBK-729 and TT-C-490.

C.3.2.1.15 System Electronics. The Debris Blowers electronics components shall be 24V DC compatible. Performance specifications shall be direct comparison to current 12V DC components on model BT-DBSML. The Debris Blowers electrical power shall be pulled from a 24V DC NATO Slave cable on the front bumper of the Buffalo MPCV.

C.3.2.1.16 A-Kit. The Debris Blower shall include an A-Kit which contains all necessary components to tie into the hydraulics and electronics of the host vehicle. The A-Kit consists of the hydraulic pump, case drain lines, hydraulic fittings, bulkhead connectors in the form of quick disconnects, the OCU wiring harnesses, flow control valves, vehicle integration bracket mounting interfaces, and OCU mounting brackets.

C.3.2.1.17 Quick Disconnect. The Debris Blower shall be equipped with quick disconnect connectors per MIL-DTL-38999 for power and communication cables, and hydraulic lines when applicable. Quick disconnect points shall occur where all components of the A-Kit interface with the B-Kit.

C.3.2.1.18 Test System Support Package. The Contractor shall submit a Test System Support Package (SSP) Component List delineating components recommended to maintain full operability during government testing in accordance with CDRL T Test System Support Package Component List 30 calendar days after contract award. Notable tests will include blowing sand, heavy rain, fording, cold and hot soak operation, and a total of 1000 miles at 2KPH -15KPH on paved roads, hilly & level gravel roads, hilly trails, and dust courses. The Test SSP Component List shall contain the following items and any other items recommended to support test: 1 hydraulic pump, 3 sets of soft hydraulic hoses, 1 turbine, 6 sets of bearings, 1 controller, 1 wiring harness, 2 hydraulics motor + seals, 2 nozzle actuation motors, 2 nozzle actuation belts, and 1 set of nozzles. The Contractor shall deliver a Test System Support Package (CLIN 0002AA) 30

C.3.2.1.19 Top Level Drawing. Contractor shall provide a system Top Level Drawing in accordance with CDRL A001 - Technical Drawing Package consisting of an assembled view of the system and an exploded view of the system with all major components/assemblies identified. Contractor shall provide a bill of materials for the Debris Blower which shall include part numbers and sources of supply in accordance with CDRL A002 Bill of Materials. Part numbers for commercial off the shelf items such as hardware, and generic components purchased from contractors vendors shall be provided.

C.3.2.1.20 Vehicle Interface Bracket. Contractor shall produce vehicle integration bracket pursuant to the Vehicle Interface Drawing Package provided by the Government as Government Furnished Information (GFI). The vehicle integration bracket is the load bearing link between the vehicle and the Debris Blower system.

C.3.2.1.21 Wiring Harness.

C.3.2.1.21.1 Hydraulic. Contractor shall provide wiring harness that shall act as interface between OCU and Debris Blower System. Harness shall be weatherproof and shall pass through the vehicle engine bay. The harness shall have heat shielding. The length of this harness shall be 20 feet.

C.3.2.1.21.2 Engine. Contractor shall utilize EHP Mine Roller wiring harness as interface between OCU and Debris Blower System. Harness shall be weatherproof and shall pass through the vehicle engine bay. Drawing for wiring harness will be provided by the US Government as GFI. The length of this harness shall be 20 feet.

C.3.2.1.22 Frame Legs. The Debris Blower shall have retractable legs that can be stowed on the frame when not in use. The purpose of the the legs is to support system service and installation onto the MPCV. Legs shall be made of aluminum.
