Boxes/pallets and any wood used as inner packaging made of non-manufactured wood shall be heat treated. All non-manufactured wood used in packaging shall be heat treated to a core temperature of 56 degrees Celsius for a minimum of 30 minutes. The box/pallet manufacturer and the manufacturer of wood used as inner packaging shall be affiliated with an inspection agency accredited by the board of review of the American Lumber Standard Committee (ALSC). The box/pallet manufacturer and manufacturer of wood used as inner packaging shall ensure traceability to the original source of heat treatment.

Each box/pallet shall be marked to show the conformance to the International Fleet Protection Convention Standard. The quality mark shall be placed on both ends of the outer packaging, between the cleats or end battens, on two sides of the pallet. In addition, wood used as dunnage for blocking and bracing shall be ordered with ALSC certified marking for dunnage or the markings may be applied locally at two foot intervals.
