STATEMENT OF WORK**STATEMENT OF WORK****C.1 Overview:**

TARDEC Ground Systems Survivability requires the contractor to provide Project Engineer services under the Computer Systems Design Services under NAICS CODE 541512. The purpose of this effort is the development of an Advanced Battery Charger Computer. A quantity of four (4) 2000 Watt (2-KW) Battery Charger Computer Systems, This will include an option to purchase up to 20 Battery Charger Computer Systems in total. The design for the systems is based upon US Government technical data package that will be provided, along with associated middleware, to the contractor upon contract award. The required period of performance is 14 weeks.

**C.2 Task Descriptions:**

2.1 The contractor shall fabricate and deliver four 2-KW Battery Charger Computer Systems based upon US Government technical data package.

2.2 The contractor shall validate the middleware on each of the Battery Charger Computer Systems prior to Government Acceptance.

**C.3 Deliverables:**

3.1 Quantity: Four (4) 2KW Battery Charger Computer Systems.

**C.4 Schedule:**

All effort performed under Task Order 0001 shall be completed by 31 DEC 14

**C.5 MEETINGS/REVIEWS/REPORTS.**

**C.5.1. PROGRAM REVIEWS.** During the course of this Contract, there shall be Bi-weekly reviews via telephone (Tel-Con) to provide program status. A meeting day/time will be mutually agreed upon by the contractor and the TARDEC Contracting Officer's Representative (COR). The COR will arrange the Tel-Con and provide a call in phone number.

**C.5.1.1. Weekly Update Progress Reports:** The contractor shall provide the Government Technical Point of Contact weekly progress reports indicating progress and how the contractor will meet the delivery schedule.

**C.5.2. FINAL SCIENTIFIC AND TECHNICAL REPORT.** The Report shall include:

1. A summary of the results of the characterization and analysis of the charger function.
2. Any issues discovered during the build and corrected action taken,
3. Recommendations that would make the unit more manufacturable,

4. Recommendations that would improve the shock/vibration durability
5. Contract cost summaries.

The Final Report shall be in a mutually agreeable format and be delivered within 30 days after the completion of the program, IAW CDRL A001. See attachment.
