Contractor shall water and fertilize all plants as required, keep plants clean and trimmed, top-dress plants as required, diagnose and treat for insects or diseases as required, perform supervisory walk-thru inspections, provide warranty to replace plants with same or similar type plant at no charge if plant should decline in appearance, due to being thin, weak, over grown or otherwise lacks in aesthetic appeal, provide (4) Bromeliads on a quarterly rotation and, include red Poinsettias for Holiday Season.

Contractor shall be for one (1) maintenance service per week for a (12) month duration and provide maintenance schedule that will not conflict with normal cafeteria operations hours.

Pesticides/insecticides must not be restricted pesticides and must be applied by a DOD certified pesticide applicator or under the direct supervision of a DOD certified pesticide applicator. Organic pesticides/insecticides are preferred.

Contractor must clean up any overspray of insecticide/pesticide immediately and take all appropriate/ necessary measures to not contaminate any food sources. COR listed below must be immediately notified of any possible contamination issues or concerns.

1. Contractor shall comply with the following installation regulations:

a. Installation Personnel Access Badge

The Installation Visitor Center will issue Access Identification Badges to approved Contractor employees working on the installation. The Contractor shall submit an application for security

Identification badge (STA Form 15) through the COR for each employee. All Contractor employees must wear badges, above the waist, at all times while on the installation. The Contractor shall ensure that badges are returned to the Directorate of Emergency Services when an individual's employment is terminated or upon completion of the contract. The Contractor shall also recover badges from employees that have departed his/her employment and retain their security identification badge. Badges may also be issued to subcontractor employees provided they require access for a continuous period of thirty (30) days or longer. The above procedure shall be followed to request badges for subcontractors. When required by the KO, the Contractor shall obtain and submit fingerprints of all persons employed or to be employed. Visiting contractor employees and short term (less than thirty (30) continuous days) subcontractor employees require issuance of non-picture contractor badges. Advance written notification shall be furnished to the COR for all required entrances to the site(s) by the above personnel.

b. Detroit Arsenal Visitor Center

The Contractor shall ensure that all employees including subcontractors are processed through the Directorate of Emergency Services and the Visitor's Center located on the Detroit Arsenal, 6501 E 11 Mile Road, Warren Michigan, Building

Number 232, to obtain badges and POV decals. Picture taking devices are not authorized on the installation without receiving approval through the visitor center, as necessary.

c. Restricted Areas and Routes

The Contractor shall not enter into any Government area which is restricted without prior authorization (i.e. work authorization showing specific work to be performed), unless notified of an emergency which required immediate attention.
